2. NOISE NUISANCE, DUST NUISANCE AND DEGRADATION TO RESIDENTS OF GANGES STREET, PRASHAD NAGAR

To date all promises made to these residents by GPL have not been fulfilled. Will the honourable Prime Minister indicate to the residents of Ganges Street who have complained about these environmental nuisances and health hazards whether their quest for mitigation measures will ever be forthcoming and if so, when and how?

4. ENFORCEMENT OF THE LAW AGAINST CERTAIN NOISE NUISANCES

Member Asking: Dr. John Austin, M.P.

Minister Answering: The Minister of Home Affairs

Could the Honourable Minister of Home Affairs inform this National Assembly what specific policing action has been taken or is proposed to be taken to enforce the laws against the creation of

a noise nuisance by:-

(i) Private transport vehicles?

(ii) Public transport vehicles?

(iii)Residential premises?

(iv) Night Clubs and other entertainment premises?

Answer:

The Honourable Minister wishes to inform the National Assembly that under Section 174A(1) of

the Summary Jurisdiction (Offences) (Amendment) Act No. 1 of 1989:

"No person shall, in any road, street, public place or land or in any building or premises, by

operating or causing or suffering to be operated any stereo set, juke box, radio, wireless loud

speaker, gramophone, amplifier, automatic piano or similar instrument of music, or by any

other means whatsoever, make or cause or suffer to be made any noise which shall be so

loud and so continuous or repetitive as to cause a nuisance to occupants of any premises in

the neighbourhood."

Subsection (2) of the said Section 174A as amended by the Summary Jurisdiction (Offences)

(Amendment) Act No. 10 of 1998, states as follow:

/...10

"Any person who contravenes the provisions of subsection (1) shall be liable on summary conviction to a fine of not less than seven thousand, five hundred dollars nor more than fifteen thousand dollars and to imprisonment for six months and on a second or any subsequent conviction to a fine of not less than ten thousand dollars nor more than twenty thousand dollars and to imprisonment for twelve months."

Further, Subsection 1 of Section 174B of the Summary Jurisdiction (Offences) (Amendment) Act as amended by Act No. 15 of 2008 states that:

"A driver of a motor bus or hire care shall not play or allow anyone to play any music in the motor bus or hire car whilst the motor bus or hire car is plying its route or parked in a public place."

Subsection (2) of the said amendment states clearly that:

"A driver of a motor bus or hire car who contravenes subsection 91) commit an offence and is liable on summary conviction to a fine of not less than seven thousand, five hundred dollars nor more than fifteen thousand dollars and to imprisonment for six months and on a second or subsequent conviction to a fine of not less than ten thousand dollars nor more than twenty thousand dollars and to imprisonment for twelve months."

(i) **Private Transport Vehicles**

Noise in private transportation can only occur where there is an annoyance to some persons as the vehicle is stopped and loud music is played at the particular area to the annoyance of residents in the area. There have been a number of such cases and action has been taken, particularly at a popular night spot in Georgetown where persons usually park their vehicles, open the trunk and play loud music.

Wherever there are incidents, the laws have been continually enforced throughout Guyana over the last year.

(ii) Public Transport Vehicles

The law as it relates to noise in public transportation has been continually enforced. A return of persons charged in 2009 is shown hereunder:

The El Nino Phenomenon

MOTIONS

<u>ITEM 1</u> - <u>STANDING COMMITTEE ON OVERSIGHT OF THE SECURITY SECTOR</u>

The Prime Minister and Minister of Public Works and Communications moved the following motion:

WHEREAS Article 119D of the Constitution provides that there shall be a Parliamentary Standing Committee established by the National Assembly with responsibility for the oversight of the security sector, namely the Disciplined Forces of Guyana;

AND WHEREAS Article 119D establishes oversight by the Parliamentary Standing Committee as being scrutiny of areas of Government policy and administration of the entities in the Security Sector;

BE IT RESOLVED:

That this Standing Committee shall be constituted as follows:

- (i) not less than six (6) and no more than ten (10) members;
- (ii) representation on this Standing Committee will be according to the proportionality of the seats held by political parties in the National Assembly;
- (iii) the Chairmanship will remain with the Government side of the House which will determine the location of the venue for meetings with the necessary secretarial support staff to allow the Committee to function in a more secure environment based on their mandate and responsibilities;

BE IT RESOLVED:

That due to the nature of this committee's responsibilities all Members will be required to take an oath of secrecy; a Member not desirous of doing so will not be entitled to sit on this Committee;

AND BE IT RESOLVED:

That the Standing Committee in the discharge of this functions shall examine the policies and administration of the entities in the Security Sector based on the Gazetted ministerial responsibilities for entities in the Security Sector under the purview of the Standing Committee, and, shall have the authority to:

- (i) define the areas of government policy and administration for its scrutiny;
- (ii) assess the performance of the Disciplined Forces vis 'a vis established targets/programmes;

- (iii) request the provision of oral and written information, including documents and records about any specific area of policy and administration of entities in the security sector unless this would compromise public safety and national security;
- (iv) review existing legislation on government policy and administration within the security sector;
- (v) summon persons within the security sector at the level of the Heads of Services, as well as hold hearings as provided for in the Standing Orders;
- (vi) utilize the services of experts and specialists as the Committee determines;
- (vii) take into account other reports emanating from agencies and Parliamentary Committees relevant to the security sector;
- (viii) submit annual reports to the National Assembly and make recommendations to the National Assembly on legislation or any other action to be taken on matters falling within their purview;

BE IT FURTHER RESOLVED:

That the Committee's authority will not include an examination of on-going operational matters of the Disciplined Forces;

AND BE IT FURTHER RESOLVED:

That this National Assembly amends the Standing Orders of the Parliament to reflect the inclusion of this new Standing Committee on Oversight of the Security Sector and its terms of reference.

ITEM 5 - NOMINATION OF MEMBERS TO THE INDIGENOUS PEOPLES' COMMISSION

Ms Gail Teixeira, M.P., (Chairperson of the Committee on Appointments), moved the following motion:

WHEREAS, Article 212S of the Constitution provides for the establishment of an Indigenous Peoples' Commission;

AND WHEREAS, in accordance with Article 212S(2) (a)(b)(c) of the Constitution, the Indigenous Peoples' Commission shall consist of –

- (a) not more than ten members, nominated by entities, by a consensual mechanism determined by the National Assembly, after the entities are determined by the votes of not less than two-thirds of all elected members of the National Assembly;
- (b) three persons, at least one being a woman nominated by the Toushaos Council and two persons including one woman nominated by Amerindian organizations determined by the votes of not less than two-thirds of all elected members of the National Assembly; and
- (c) a member who shall be a nominee, without the right to vote, chosen by and from each of the following Commissions: the Human Rights Commission, Ethnic Relations Commission, Women and Gender Equality Commission and the Rights of the Child Commission."

AND WHEREAS, in keeping with article 212S(2)(a), the Committee on Appointments, having deliberated on the identification of the entities for nomination to the Indigenous Peoples' Commission unanimously agreed on the following entities to nominate one person each as members of the Indigenous Peoples' Commission:

- The Amerindian Research Unit, University of Guyana
- Environmental Protection Agency
- Ministry of Amerindian Affairs
- Private Sector Commission
- Ministry of Labour, Human Services and Social Security
- Ministry of Health; and
- Guyana Council of Churches

AND WHEREAS, the Committee also unanimously agreed on the consensual mechanism, to guide the process for consultation and nomination of Members to the said Indigenous Peoples' Commission with reference to article 212 S(2) (a) herein at the First Schedule;

AND WHEREAS, the Committee invited the National Toushaos Council and the four(4)Amerindian organizations namely, the Guyana Organisation of Indigenous People (GOIP), the Amerindian Peoples' Association (APA), the Amerindian Action Movement (TAAMOG), and the National Amerindian Development Foundation (NADF)to submit their nominees.

AND WHEREAS, the Toushaos Council on December 10, 2009, submitted their three (3) nominees to the IPC namely: Toushao Yvonne Pearson; Toushao Doreen Jacobis and Toushao Marco J. De Souza.

AND WHEREAS, the four Amerindian organizations submitted five (5) nominees and the Committee on Appointments, on 4th December, 2007, through a process of selection, recommends the following two (2) names: **Mr. David James and Ms. Matilda Saigo.**

That this National Assembly approves the list of entities proposed in the second "And Whereas "clause, to be consulted to nominate members of the Indigenous Peoples' Commission in keeping with article 212 S(2) (a);

FIRST SCHEDULE

Consensual Mechanism for the Nomination by Entities for Members of the Indigenous People's Commission

Each entity, immediately on the passage of this motion, shall be written to by the Clerk of the National Assembly inviting it to meet and select their nominee and to send a representative/s on an appointed day/date, time to appear before the Parliamentary Standing Committee to Appoint Members of Commissions, at the Parliament Buildings to present the name/s of their nominee/s for Membership on the Indigenous People's Commission.

A deadline shall be set by the Clerk of the National Assembly on the advice of the Standing Committee, by which time it would be formally notified of the names and other requested particulars of the Nominee/s, the process used for the selection of the Nominee/s by the entity, and a statement to the effect that the Nominee/s is/are supported and accepted by that entity.

The Nominee/s chosen to represent the Group must be person/s who are competent to contribute positively to the work of the Commission and who are committed to ensuring that it discharges all of its functions. They should have earned public respect and be of unquestionable honesty and integrity.

The process used must be demonstrated to be unbiased and transparent. It is important that the Nominee/s obtain the unquestioned support and acceptance of the Entity.

Where there is a recognized "umbrella organization" in the list of entities for that Group, the Clerk shall write to that organization and copy his letter to each of the "constituent entities" within the Group.

ITEM 6 - COMPLIANCE WITH THE INTEGRITY COMMISSION ACT

At the request of the Prime Minister and Minister of Public Works and Communications the following motion was deferred:

WHEREAS the extant Integrity Commission Act was passed in this House in 1997 and made into law on September 24, 1997 as the Integrity Commission Act 1997, Chapter 19:12, Act No. 20 of 1997;

AND WHEREAS the Commission and support staff were established shortly thereafter and all persons in public life listed in Schedule 1 being persons of high office are expected to be in compliance with this law;

AND WHEREAS Section 19 of the Act empowers the Commission and the President to publish the names of persons who are not in compliance with this Act in the Gazette and in a daily newspaper;

AND WHEREAS Section 22 addresses the offences and penalties for failure to comply which include fines and imprisonment;

AND WHEREAS all elected officials, and more so, Members of Parliament in particular, identified in Schedule 1, are expected to be standard bearers of ethics in public office and uphold the Code of Conduct outlined in the Act and in Schedule II,

BE IT RESOLVED:

That this House recognizes the lawful and legal obligation of Members of Parliament to submit declarations and call on all Members of this National Assembly to submit forthwith;

BE IT ALSO RESOLVED:

That this House conducts an annual voluntary monitoring exercise of compliance by Members of Parliament;

BE IT FURTHER RESOLVED:

That this House declares that failure or refusal of Members of Parliament to submit annual declarations is a violation of the law and a gross indictment of those Members.
