Answers

- The Municipality of New Amsterdam received a first tranche on its subvention of \$10 million for 2009 in that same year. The final tranche was released in June, 2010. The delay was due to the Council's late submission of its financial Statement to the Auditor General. The submission of the statement is a condition for releasing final payment.
- 2. The Municipalities of Corriverton, Rose Hall and New Amsterdam received their releases of \$4m, \$4m and \$5m respectively for the year 2010 in September of 2010.
