The Minister of Agriculture moved the following amendment which was <u>put</u> and <u>carried</u>: Clause 40((2)(p) - delete the word 'certification'

Clause 40 was then passed as amended.

In the marginal notes, delete the word 'defense' and insert the word 'defence'

Clause 31 was then passed as amended.

Clause 32 and 33 were passed as printed.

Clause 34

The Minister of Agriculture moved the following amendments which were put and carried:

Insert the following clause as clause 34 –

"Savings 34(1) the Plant Protection Act is repealed. and repeal Cap.68:03

> (2) All applicable subsidiary legislation made under the repealed Act, not inconsistent with this Act, shall continue to apply as if they were made under this Act unless or until revoked or amended under this Act."
