INTRODUCTION OF BILLS-

Presentation and First Reading

CARIBBEAN COMMUNITY (Free Entry of Skilled Nationals) (AMENDMENT) BILL 2011 – Bill No. 12/2011

The Minister of Foreign Affairs, on behalf of the Government, presented the following Bill, which was read the first time:

A BILL intituled AN ACT to amend the Caribbean Community (Free Entry of Skilled Nationals) Act.

PROTECTED AREAS BILL 2011 - Bill No. 11/2011 published on 2011-06-20

The Minister of Agriculture moved the second reading of the following Bill:

A BILL intituled AN ACT to provide for the protection and conservation of Guyana's natural heritage and natural capital; the creation, management and financing of a national system of protected areas; the maintenance of ecosystem services of national and global importance including climate regulation; the establishment of a protected areas commission; the establishment and management of a protected areas trust fund; the fulfillment of Guyana's international environmental responsibilities; public participation in protected areas and conservation; and related purposes.

While the Prime Minister and Minister of Public Works and Communications was speaking to the motion the Speaker withdrew from the Chamber.

Presiding by Mrs. Clarissa Riehl, M.P.

At 3.50 p.m., the Speaker withdrew from the Chamber and Mrs. Clarissa Riehl, M.P., Deputy Speaker of the National Assembly took the Chair.

Speaker's Return to the Chamber

At 3.56 p.m., the Speaker returned to the Chamber.

Thereafter the Minister of Agriculture replied.

The Bill was then read a second time.

The Assembly resolved itself into Committee to consider the Bill clause by clause.

In Committee

Clauses 1 and 2 were passed as printed.

Clause 3

Mr. Mervyn Williams moved the following amendments which were <u>put</u> and <u>negatived</u>:

"Clause 3(a) –

Insert the word 'Savannahs' after the word 'seascapes'

Clause 3(g) –

Delete the word 'and', replace it by a comma and insert the words 'and other non-Amerindian communities' after the words 'Amerindian Communities'

Clause 3(m)-

Insert an additional clause-

'to institute measures in conjunction with the Wildlife Division, to regulate harvesting and exploitation of species which are vulnerable or threatened'"

Clause 3 was then <u>passed</u> as <u>printed</u>.

Clause 4

Mr. Mervyn Williams moved the following amendment which was <u>put</u> and <u>carried</u>:

"Clause 4(f)-

Delete the words 'and offered opportunities for employment' and replace them with the words 'relevant to job placement opportunities'"

Clause 4 was then passed as amended.

Clause 5 was passed as printed.

Clause 6

Mr. Mervyn Williams moved the following amendment which was put and carried:

"Include a definition for 'Special Grant Programme"

Clause 6 was then passed as amended.

Clauses 7 and 8 were passed as printed.

Clause 9

Mr. Mervyn Williams moved the following amendment which was put and negatived:

"Clause 9(c) -

Insert the words 'and use of' after the word 'in'"

Mr. Mervyn Williams moved the following amendment which was put and carried:

"Clause 9(e)-

Insert the words 'classification and' after the first 'the' in the clause."

Clause 9 was then passed as amended.

<u>Clauses 10 to 24</u> were <u>passed</u> as <u>printed</u>.

Clause 25

Mr. Mervyn Williams moved the following amendment which was put and carried:

"Delete the word 'is' and replace it with the word 'be' and delete the word 'as"

Clause 25 was then passed as amended.

Clauses 26 and 27 were passed as printed.

Clause 28

Mr. Mervyn Williams moved the following amendment which was put and negatived:

"Clause 28(2)-

Insert the words 'and involved' after the word 'consulted'"

Clause 28 was then passed as printed.

<u>Clauses 29 to 37</u> were <u>passed</u> as <u>printed</u>.

Clause 38

Mr. Mervyn Williams moved the following amendment which was <u>put</u> and <u>negatived</u>:

"Delete clause 38(2)"

Clause 38 was then passed as printed.

Clause 39

Mr. Mervyn Williams moved the following amendment which was put and negatived:

"Clause 39(1)-

Delete the words 'or in his own judgment' and delete the second 'by'"

Clause 39 was then passed as printed.

Clauses 40 to 74 were passed as printed.

Clause 75

Mr. Mervyn Williams moved the following amendment which was <u>put</u> and <u>carried</u>:

"Delete the words 'not less than every five years' and replace them by the words 'every five years'"

Claus 75 was then passed as amended.

Clauses 76 to 122 were passed as printed.

Clause 123

Mr. Mervyn Williams moved the following amendment which was put and carried:

"Delete the words 'except authority"

Clause 123 was then passed as amended.

Clauses 124 to 131 were passed as printed.

The Schedules were passed as printed.

Assembly resumed

On a motion by the Minister of Agriculture, the Protective Areas Bill 2011 was read a third time and <u>passed</u> as <u>amended</u>.
