Provided that -

- (a) the elections of Mayors and Deputy Mayors shall proceed in accordance with the provisions of sections 9(1) and 13(1) of Municipal and District Councils Act, Chapter 28:01, and
- (b) the elections of Chairmen and Deputy Chairmen shall proceed in accordance with the provisions of section 5A of the Local Democratic Organs Act 1980 and section 28 of the Local Government Act, Chapter 28:02".

The Minister of Local Government and Regional Development spoke to the amendment.
