- This is the rainy season and the total acreages are still under cultivation. Therefore, the total cultivated acreages for 2002 including total crop damage and effectiveness of pest control will only be available at the end of the rainy season.
- The figures presented for Region 8 are estimates obtained for the 2001 season (attached). Figures for the Takutu areas of sub-region 1 - Region 9 are unavailable. In the Takutu area the highest cultivation are cassava and peanuts.
- The General objective for Hinterland agriculture: To encourage agricultural development in Regions 1, 7, 8 & 9 to the extent that production does not exceed the ability of the producers to dispose of the produce within these areas.

This objective is to ensure food security and sustainability.

(ii) The fern is secondary growth after the removal of the forest. This growth only take place in moist conditions. There was never a complaint to the hinterland unit for the control of the fern. The farming techniques use in the hinterland aids in natural control of the fern.

It must be noted that there are two types of ferns that are present in the farms. Both types are not problems.

Replies submitted by the Minister of Agriculture;

- (i) (a) The Drainage and Irrigation Board has no responsibility. All duties and responsibilities are vested in the East Demerara Water Conservancy Board.
 - (b) The Chairman of the Drainage and Irrigation Board has no legal responsibility in regard to the East Demerara Water Conservancy.
- (ii) Three major embankment failures occurred in 2000 at Lusigana, Hope and Maduni and one in 2001 at La Bonne Mere.
- (iii) No determination was made on the amount of water lost during these breaches in the dam.
- (iv) Following the La Bonne Mere breach, the Cane Grove area was affected and the Government expended approximately \$20M as compensation to residents. The Maduni breach resulted in no community being affected. The breaches at Lusignan and Hope caused some discomfort to the affected villages and their environs due to flooding but no survey was carried out to determine the amount of losses suffered by residents.
- (v) The cost of corrective works to breaches at Maduni and Lusignan were \$31.4M and \$18.0M respectively. Repairs at Hope and La Bonne Mere were carried out within the existing contracts for works on the East Demerara Water Conservancy.
- (vi) This varies annually depending on the amount of maintenance to be carried out during the year. However, the figures for 2001 and 2002 are approximately \$30.0M and \$31.0M respectively.

- (vii) No consultancy firm was engaged during this period. The contracting firm, BK International Inc. was engaged to carry out rehabilitation work on the East Demerara Water Conservancy.
- (viii) The cost of the works carried out under contract on the East Demerara Water Conservancy and funded by the Inter-American Development Bank is \$452.7M.
- (ix) The lowest responsive bids were awarded the contracts and these awards were concurred by the Inter American Development Bank.

STATEMENTS BY MINISTERS -

Attack on the Office of the President on Wednesday, 3rd July, 2002

The Hon. Clement J. Rohee, Minister of Foreign Trade and International Co-operation made the following statement on the attack and storming of the Office of the President complex on Wednesday, 3rd July, 2002:-

⁴⁴ Wednesday 3rd July, 2002 marks another dark and dismal day in the history of the PNC when its organized protesters attacked and stormed the Office of the President complex with the clear objective of making an attempt on the life of His Excellency, President Bharrat Jagdeo and overthrowing the democratically elected PPP/Civic Government on the same day on which commenced the 23rd Heads of Government meeting being hosted by Guyana and at which our President was to assume the Chairmanship of CARICOM.

This act and the other acts of violence resulting in the burning down of business places, the torching of cars and assaults and robberies and other acts of violence committed on peaceful and law-abiding citizens, including law enforcement ranks have been roundly condemned by most citizens and nearly all sectors of Civil Society.

The citizens and Government of Guyana also welcomed the condemnations by CARICOM Heads and by the Governments of the United States of America, the United Kingdom and Canada. The statements of their commitment to the preservation and protection of democratic governments such as Guyana is most welcomed and show that the era of violence, extraparliamentary behaviour and unconstitutional acts will not be condoned by the international community.

On behalf of all law abiding Guyanese, I wish to state our thanks and appreciation to our Security Forces for thwarting an attempt to overthrow the democratically elected Government. They continue to maintain their high standard of professionalism and the carrying out of their duties under the Constitution.

Mr. Speaker, we must also recollect that on May 24th, 2002 there was an attempt to blockade Parliament and deny access to those Parliamentarians who wished to attend and perform the mandate for which they were elected. We have seen that some of the individuals from the PNC/R involved in that disgraceful act were also involved in the illegal marches and the subsequent storming of the Office of the President on July 3, 2002

These actions clearly illustrate the illegal and unparliamentary and terroristic behavior and intentions of certain elements in the PNC/R, which must be opposed exposed and condemned by the entire country.

If the PNC/R is interested in contributing to the growth of our democracy and the progress and prosperity of all Guyanese then it must purge itself of such violent and disruptive tendencies. As a first gesture, the PNC/R must return to Parliament to fulfill the mandate of those who voted for that party at the March 2001 general and regional elections.

Again, I wish to applaud representatives of political groups, including several prominent PNC/R members, civil society, the international community and all law abiding Guyanese for condemning and taking a firm stand against Wednesday, July 03, 2002 acts of domestic terrorism, ³⁾

ITEM 1 - ACCESS TO THE OFFICIAL GAZETTE

Mrs. Sheila Holder moved the following motion and amendment:

<u>Motion</u>

WHEREAS many citizens of Guyana with great sacrifice acquire title to land for their domestic security or as an economic investment; and

WHEREAS immovable property can be fraudulently transferred by means of forgery of documents or false claims; and

WHEREAS all such dealings in land are required to be advertised in the Official Gazette which, although published weekly, is not easily accessible to the general public who are likely to be affected by any fraudulent transactions.

BE IT RESOLVED that this National Assembly urge the administration to take immediate steps to ensure that the public have easy, timely and unhindered access to the Gazette at all Post Offices, Regional Offices, Magistrates Courts and other public places and by purchase from governmental agencies and bookstores.

ITEM 2 - INCREASE IN TARIFF RATES - GUYANA POWER & LIGHT CO. (G.P.L.) Mrs. Sheila Holder moved the following motion:

Motion

WHEREAS the supply of electricity is an essential service for the well being of citizens of Guyana as far as their social, economic and environmental development are concerned;

AND WHEREAS the public utility, the Guyana Power & Light Co. (G.P.L.) is a monopoly operating in circumstances where there is no fixing of rates by a regulatory authority;

AND WHEREAS as a consequence there is no process for the containment of G.P.L.'s monopolistic market control.

BE IT RESOLVED:

That this National Assembly disapproves the recent increase tariff rates by the Guyana Power & Light Co.

The following amendment by the Prime Minister was agreed to:

Deletion of all the words from the beginning of the second WHEREAS clause to the end of the motion and the substitution therefor of the following:

"AND WHEREAS every consumer has a right to self generate, and the utility is required to consider proposals from others to meet its projected generation needs but the utility has the monopoly to market electricity to the public;

AND WHEREAS the Government recognizing the need for the sustainability of the utility to be assured, put in place a certain and transparent procedure for the annual review of rates to satisfy the needs of an efficiently and effectively run utility'

AND WHEREAS the Government has expressed its dissatisfaction with any rate increase resulting from poor performance of the utility:

BE IT RESOLVED:

That this National Assembly urge the Public Utilities Commission to examine and remedy issues of non performance on the part of the utility."

The motion as amended was seconded by Mrs. Shirley Melville.

The following Members spoke to the motion: The Prime Minister Mrs. Shirley Melville

Thereafter, Mrs. Sheila Holder replied.

The motion as amended was then put and carried.
