# STATEMENTS BY MINISTERS -

## POTABLE WATER SUPPLY SITUATION IN LINDEN

The Minister of Housing and Water made the following statement:-

"As a result of the inability of the Linden Power Company to supply electricity to Linden over the past week, the supply of potable water by the Guyana Water Inc., to the Linden population has come to a halt. The Linden Water Supply Scheme is designed to provide approximately 31,000 inhabitants with potable water and depends on five water treatment plants to pump water into the transmission and distribution system. The five water treatment plants are located at Wisroc, West

Watooka, Wismar, McKenzie and Amelia's Ward. These plants are all dependent on electric power to become operational. The Ministry of Housing and Water and Guyana Water Inc., is very concerned about the situation and is putting in place emergency measures to enable the residents of Linden to receive supplies of water.

Firstly, efforts are underway to put into operation the Amelia's Ward Plant. A Generating Set has been sent to provide power. If all goes well, we are hoping that the Amelia's Ward Plant will be in operation today. From this plant, GWI will truck in supplies of water to various locations in Linden.

Secondly, the Ministry is trying to source at least two 250-300KVA generating sets to be used to independently power two of the remaining water treatment plants. It is expected that once these are in operation the water situation will be much relieved. The Ministry and GWI will be working round the clock to effect emergency solutions to bring relief to the much-pressed residents of Linden.

I wish to bring to the attention of the National Assembly that GWI has a plan for the rehabilitation of the Linden Water Supply System. When GWI took over the Linden Water Supply in October, 2001, it was in a state of collapse. In year 2002 nearly \$50m was spent in upgrading the water supply system. Only last Thursday, GWI signed an Agreement with the European Union for nearly \$200m to further rehabilitate the water system. This will be done in three phases. Phase 1 will commence immediately and will target the Wisroc Water Treatment Plant, refurbishment of the Wisroc Elevated Tank, install transmission lines and rehabilitate internal storage and pipe network at Wismar Hospital. This phase will also construct a new aerator at the Amelia's Ward Treatment Plant, Phases 2 and 3 will further upgrade the Water Supply System.

Finally, I wish to assure this Honourable House, that the Government is taking the necessary measures to bring relief to the residents of Linden to restore electricity supply to Linden, and Mr. Speaker, as I speak now, I have been informed by Linmine and GWI that one of the generating sets

is now operational and supplying power to the Water Treatment Plants. It is expected that the other set will also be in operation later today. The Government is also taking measures in providing access to supplies of potable water and to continue the programme to rehabilitate the Linden Water Supply System."

## PERSONAL EXPLANATIONS -

## (i) MARCH 28, 2003, DEMONSTRATION BY THE PNC/R

The Minister of Culture, Youth and Sport gave the following personal explanation:-

"Hon Members, I wish to raise a point of privilege with reference to the March 28, 2003, demonstration by the PNC/R. On that occasion the demonstrators blocked the egress and ingress of other Ministers of the Government, Members of Parliament and myself to the Ocean View International Hotel where Parliament was sitting.

Whilst recognising people's right to demonstrate, I have to point out that there are norms governing the lawful expression of one's concerns. The March 28, 2003, demonstration did not follow the norms and behaviour, I therefore request that the unbecoming behaviour of the PNC/R M.P.s be referred to the Committee of Privileges for examination, advice and action where necessary."

# (ii) <u>PICKETING EXERCISE BY PNC/R MEMBERS OF PARLIAMENT ON 28</u><sup>TH</sup> <u>MARCH, 2003</u>

The Minister of Health gave the following personal explanation:-

"I stand regrettably to raise an issue that not only all Guyana observed, but was displayed for people internationally to observe. I refer to the actions of a small group of people on March 28<sup>th</sup> that lead to you having to adjourn Parliament and then for the adjournment to become protracted due to

the invasion of the halls of Parliament by Members of Parliament from the People's National Congress.

Mr. Speaker, this House, the Government of Guyana and the Constitution uphold the rights of all citizens to peacefully picket. The picketing exercise which was led by Members of Parliament from the People's National Congress was not a peaceful one. Members of Parliament who belong to the PNC were seen not only as part of the small group of protestors, but giving encouragement to others to block vehicles and impeding the entry of other Members of Parliament. The Honourable Minister of Home Affairs had to abandon his vehicle and walk through the threatening protestors in order to get to the Parliament and discharge his duty as an elected Member. The Honourable Member Deborah Backer decided to stand in front of my vehicle preventing me access to Parliament. Other Members of Parliament from the PPP/C suffered the same faith.

These same Members encouraged the small crowd to break down police barriers to invade the precinct of Parliament, ignoring police instructions. This behaviour in no way constitute peaceful picketing. The small crowd, including women and children came with sticks and threaten to break the windows of the building as they beat on the floor and walls of the building, threatening the police and others.

The commotion, noise and threatening sounds coming from just outside of the building and within the precinct of Parliament forced the Parliament to recess and the Minister to stop his presentation.

The invasion of Parliament by the Members Jerome Khan and Abdul Kadir with pickets in hand and the entrance into the hall of protestors Vincent Alexander and Deborah Backer are a violation of the decorum to which all of us subscribe. This behaviour should be roundly condemned in the most unequivocal way.

Mr. Speaker, this House functions within a democracy. All the Members of this House were elected in free and fair elections. While it is a privilege, it is also a serious obligation. We were elected to serve the people of Guyana. While we disagree on many things, our mandate is to serve in this House to protect and promote the people's interest.

Nothing is gained by staying out of Parliament. Certainly nothing can be gained by Members who indulge in holliganism and in criminal activities. We have been privileged to be elected and we are paid for the privilege of serving people in this House. While there is a constituency that may have elected each one of us, we all serve all the people of Guyana.

Our history is one in which for more than two decades after independence we lived in a dictatorial environment. Our history is that we had to fight against the most sordid attempts at destroying all democratic institutions in this country, including the symbol of a democracy, Parliament. That era spawned the worst examples of dictatorial behaviour and practices. The most brutal actions were taken to deal with those who dared to stand up against the dictatorship.

People were beaten and locked up. People were charged with the worst kind of trump-up charges. And yes, Mr. Speaker people were killed for standing up to the dictatorship.

That era served to incubate proponents of anarchy and brutal dictatorship. That era served to incubate leaders bent on challenging democratic processes and institutions.

At a time we talk about inclusiveness and shared governance, we need to appreciate what these hallowed terms mean. Shared governance obligates each one of us in this House to perform certain duties. The work of this House is not about any one of us having our own way. It is about debating the issues and participating in the work of the committees. It is not about just receiving duty free cars and getting a monthly salary."
