ITEM 1 - ESTABLISHMENT OF A PARLIAMENTARY MANAGEMENT COMMITTEE

The Minister of Culture, Youth and Sport moved the following motion:

WHEREAS after discussions, arising from the agreement arrived at and recorded in paragraph 3H of the St. Lucia Statement of 2nd July 1998, the Political Parties represented in the National Assembly have agreed that a Parliamentary Management Committee shall be established by the National Assembly on certain terms and conditions.

BE IT RESOLVED:

1.

That this National Assembly of the Parliament of Guyana approves of the establishment of a Parliamentary Management Committee (hereinafter referred to as "the Committee") which shall comprise representatives from the Parties represented in the National Assembly, to consider and decide on the matters relating to:

- The business of the National Assembly;
- Such other matters which the Committee may wish to consider; and
- Such other matters referred to it by the National Assembly.
- That the Committee shall report to the National Assembly from time to time on such matters which it considers necessary to bring to the attention of the National Assembly or as the National Assembly may require.
- 3. In the event that the Committee is unable to arrive at a decision on an issue, or it has not been possible to convene a meeting because of a lack of quorum as provided for in Clause 8, the Chairman of the Committee shall so inform all Members of the Committee and the Committee shall seek direction from the National Assembly on the resolution of that issue.

That the composition of the Committee shall be five (5) from the PPP/C, three (3) from the PNC/R, one (1) from the GAP/WPA and one (1) from ROAR.

That the Committee shall be chaired by the Speaker of the National Assembly and, in his or her absence, the Deputy Speaker of the National Assembly. The Chair of the Committee shall neither have an original nor a casting vote.

- That the nomination of Members to the Parliamentary Management Committee and the subsequent filling of vacancies shall be made by the Committee of Selection.
- That the National Assembly adopts and approves the decisions of the Committee of Selection at its meetings held on Friday, 4th April, 2003 and Wednesday, 9th April, 2003 relating to the composition, membership and other matters relating to the Parliamentary Management Committee.
- A quorum shall be four (4) Members, two (2) Members representing the Government and two (2) Members representing the Opposition, one (1) of whom shall be a representative of the main Opposition Party, together with the Speaker or Deputy Speaker in the absence of the Speaker. If a meeting of the Committee is fixed and cannot be held for the lack of a quorum, the Members of the Committee shall be given forty eight (48) hours notice of the holding of another Meeting at which other Meeting the Members present shall comprise a quorum provided at least one member of the Opposition is present.
- 9. Except where the terms of this Motion provide otherwise the procedure relating to Standing Committees of the National Assembly, as provided for by Standing Order 70A, shall apply to this Committee. The terms herein shall apply where there is conflict with the Standing Orders.

ITEM 2 -MODALITIES TO GIVE EFFECT TO PROVISIONS OF ARTICLE 119C


The Minister of Culture, Youth and Sport moved the following motion:

WHEREAS in respect of each Commission in Column 1 of the TABLE the National Assembly has in relation to the corresponding article in Column 2 of the TABLE the power mentioned in Column 3 of the TABLE;

Judicial Service Commission	198 (2) (b)	the meaningful consultation with such bodies as appear to it to represent attorneys- at-law in Guyana to be done by the National Assembly and the signification of its choice of members to be made to the President
Public Service Commission	200 (1) (b)	two members appointed by the President upon nomination by the National Assembly after it has consulted such bodies as appear to represent public officers or classes of public officers
Police Service Commission	210 (1) (c)	four members appointed by the President upon nomination by the National Assembly after it has consulted such bodies as appear to it to represent the majority of the members of the Police Force and any other such body it deems fit

Public Procurement Commission	212X.(1) and (2)	the five members of the Public Procurement Commission should have expertise and experience in procurement, legal, financial and administrative matters and be nominated by the Public Accounts Committee and approved by not less than two-thirds of the elected members of the National Assembly.

AND WHEREAS article 119C reads -

"There shall be a Standing Committee of the National Assembly which shall have the responsibility for initiating or otherwise taking such action or addressing such matters as may be entrusted to the Committee by the National Assembly in respect of functions required to be discharged by the Assembly under the Constitution in relation to the appointment of a member of a Commission established under the Constitution."

NOW, THEREFORE, BE IT RESOLVED that "the Standing Committee, to address matters relating to the appointment of members of Commissions established under the Constitution", appointed by the Committee of Selection on April 4, 2003, as provided for by and pursuant to article 119C of the Constitution and under the provisions of Standing Order 70A:

11.

- (a) shall identify the appropriate bodies for consultation in the appointment of the relevant members of the Commission, conduct the necessary consultations with them and, where necessary, receive nominations from appropriate bodies;
- (b) shall make recommendations to the National Assembly:
- (i) for a Consensual Mechanism for the Ethnic Relations Commission, the Women and Gender Equality Commission, the Indigenous Peoples' Commission and the Rights of the Child Commission;
- (ii) for the appointment of members of the Commissions with the exception of the Public Procurement Commission; and
- (iii) in connection with any other matter referred to it by the National Assembly from time to time.
- (c) shall report to the National Assembly in relation to each Commission as soon as possible upon the discharge[d] of its function in relation thereto.

BE IT FURTHER RESOLVED that this National Assembly approves that the undermentioned entities shall be included among the entities to be consulted in respect of the appointment of the Service Commissions mentioned below:

the Guyana Bar Association and the Guyana Association of Women
Lawyers; with respect to the Judicial Service Commission

ii the Guyana Public Service Union and the Senior StaffAssociation with respect to the Public Service Commission; and

the Guyana Police Association, the Association of
former members of the Guyana Police Force and the National Community
Policing Executive with respect to the Police Service Commission.
