No. 1 - TRACTOR AT PARAMAKATOI

Mrs. Sheila Holder asked the Minister of Local Government and Regional Development the following questions:

- 1. *Who has been assigned responsibility for the tractor and the tractor operator/driver currently in operation at Paramakatoi?
- 2. *From whom should the tractor operator take instructions regarding the use of the tractor at Paramakatoi?
- 3. *Under what conditions and/or circumstances were the tractor and its operator provided to Paramakatoi?

(Notice Paper No. 8(Q1 Opp1) published 2003-02-17)

Oral Answer by the Minister of Local Government and Regional Development

- The Regional Executive Officer of Region 8 has responsibility for the tractor and operator/driver at Paramakatoi.
- (ii) The tractor operator takes instructions for the use of the tractor from the Regional Executive Officer, Region 8, through the Hinterland Affairs Worker based at Kato.
- (iii) The tractor was acquired during the year 1999 with funding of \$6M provided by the Regional Democratic Council and \$1M provided by the Villages of Kato (\$500,000) and Paramakatoi (\$500,000).

The operator was trained and employed by the Regional Democratic Council. The tractor is used to assist in village projects throughout the sub-region. All fuel and maintenance expenses and payment to the tractor operator are bourne by Region 8 RDC.

No. 2 - TRAIL FROM PARAMAKATOI TO BAMBOO CREEK

Mrs. Sheila Holder asked the Minister of Local Government and Regional Development the following question:

*Would the Minister say what plans are in place to maintain and or upgrade the trail from Paramakatoi to Bamboo Creek?

Oral replies by the Minister of Local Government and Regional Development

"The trail from Paramakatoi to Bamboo Creek is being maintained and upgraded with funds provided by the Regional Democratic Council, Region No. 8 from its budgetary allocation."

<u>No. 3</u> - MAINTENANCE OF HINTERLAND AIRSTRIPS

Mrs. Sheila Holder asked the Minister of Transport and Hydraulics the following questions:

 *Is there a public tendering system in place for the awarding of contracts for the maintenance of airstrips in the hinterland? If so, could the Minister please say if it is on an annual basis and when last was the process used?

2. *What system is in place to ensure that equal treatment and equal opportunity are available to indigenous hinterland residents to bid for such contracts?

Oral replies by the Minister of Transport and Hydraulics

Ouestion 1.

"There are two types of maintenance works which are carried out on hinterland airstrips; a quarterly routine maintenance and a corrective or rehabilitative maintenance.

In the case of the corrective maintenance this is done through a system of public tendering. Whenever funds are provided in the budget for such works, particularly airstrips, a system of public tendering is used. The system of public tendering was last used in July 2002. This was in respect of seven (7) airstrips.

Whenever such contractual works are carried out the residents in the area are employed by the contractor.

With reference to the quarterly routine maintenance which is for amounts ranging from \$80,000 to \$120,000 per quarter - and this range depends on the size of the airstrip - it has been the practice for such maintenance works to be carried out by residents of the respective areas."

Question 2

"The Aerodrome Section has always tried to ensure that equal treatment and opportunity are available to the indigenous hinterland residents. In consultation with the Regional Administration, thirty (30) contractor, referred to as resident contractors, were hired. These are persons who reside in the community in which the airstrip is located or who live in close proximity to the airstrip. Of the thirty (30) contractors seventeen (17) are indigenous residents and one (1) from Anna Regina.

The seventeen (17) airstrips where the indigenous residents are contracted are: Region 1 -Matthews Ridge and Kaituma; Region 7 - Kamarang, Irecheng, Baruma and Kaikan, and there are about three (3) in Regions 6, 8, 9."
