(2B) The substantive offices of Governor and Deputy Governor shall not remain vacant for a period in excess of six months of becoming vacant."

The amendment was put and carried.

The following amendment by Mr. Jerome Khan was <u>put</u> and <u>negatived</u>:

by the insertion in section 9(1) of the following paragraph after the word, "Board"
"(d) one of whom shall be a nominee of the major parliamentary opposition party."

Clause 2 was then passed as amended.

Clauses 3 to 7 were passed as printed.

#### Clause 8

The Minister of Finance moved the following amendment:

Insert immediately after clause 7 the following-

"Insertion of new section 58A in the

8. The Principal Act is hereby amended by the insertion immediately after section 58 of the following as section 58A-

Principal Act.

'Internationally 58A. The Board shall at all time ensure that the books and accepted records of the Bank, including its financial statements accounting are prepared and maintained in conformity with standards. internationally accepted accounting standards.'."

The amendment was put and carried.

Clause 8 was then passed as amended.

The Schedule was passed as printed.

#### Assembly resumed.

On a motion by the Minister of Finance the Bank of Guyana (Amendment) Bill - Bill No. 20/2004 was read a third time and <u>passed</u> as <u>amended</u>.
