1. <u>LEGISLATION TO REGULATE THE FUNCTIONING OF COMMUNITY</u> POLICING IN GUYANA

Mr. Raphael Trotman asked the Minister of Home Affairs (a.g.) the following question:

Does the Government have a plan to introduce legislation to regulate the functioning of community policing in Guyana, and if so, when? (Notice Paper No. 125 (O62 Opp61) published on 2004-10-26)

Written reply submitted by the Minister of Home Affairs (a.g.)

No, the Government has no current plans to regulate by legislation a service that is being voluntarily provided.

2. PROCUREMENT OF WEAPONRY FOR THE SPECIAL WEAPONS AND TACTICS TEAM

5. VIOLENT CRIME ON THE EAST COAST OF DEMERARA

Mr. Raphael Trotman asked the Minister of Home Affairs (a.g.) the following question:

What measures will the Government take to reduce the incidence of violent crime on the East Coast of Demerara? (Notice Paper No. 130 (Q67 Opp66) published on 2004-10-26)

The Government supports the operational plans being employed in the overall strategy of the Guyana Police Force as appropriate.

At a policy level, the Government continues to permit Community Policing.

6. **<u>GUYANA FIRE SERVICE</u>**

Mr. Raphael Trotman asked the Minister of Home Affairs (a.g.) the following questions:

Can the Minister say:

- (i) What, if any, are the plans to immediately improve the material capability of the Guyana Fire Service to address fires destroying dwellings and businesses alike?
- (ii) Does the Government intend to purchase a fire boat or boats?
- (iii) How many fire tenders are in operation in Georgetown?
- (iv) Will the Government establish fire stations on the East Coast and East Bank of Demerara?

(Notice Paper No. 141 (Q78 Opp77) published on 2004-10-26)

Written replies submitted by the Minister of Home Affairs (a.g.)

(i) The Guyana Fire Service through the Guyana Government has received funding for the purchase of a Land Rover Type Fire Appliance, valued at fifteen million, six hundred thousand dollars (\$15,600,000.00). The order for this vehicle has already been placed.

Government has also approved the purchase of a second Land Rover appliance along with protective fire fighting equipment such as:

- (a) Protective Clothing
- (b) Breathing Apparatus Sets
- (c) Other ancillary fire fighting equipment

This will be done before the end of this year 2004.

- (ii) The Government and the Fire Service's Administration are aware of the need for a Fireboat, which will greatly assist in fire fighting operations if necessary on the water front. Having a Fireboat will also give support to land base fire fighting operations. However, the cost of acquiring such a boat will be over three hundred million (\$300,000,000.00) Guyana dollars.
- (iii) At present in the city of Georgetown there are two Water Tenders, one Water Carrier and three portable Pumps.

(iv) Both the Government and the Guyana Fire Service have recognised that there is growing expansion in the housing and commercial sectors throughout the Country. As such we see the need in establishing Fire Service presence in those areas which are becoming highly populated over the next five years.

In this regard a new Fire Station was completed in Anna Regina in 2003.

At present a contract has been awarded for the building of a Fire Station in Linden. Works have already started on site preparation. This Station should be completed in 2005.

In keeping with this trend, as part of the Fire Service's Capital Budget for the next four years, plans are in place to build Fire Stations along West Coast Berbice, East Coast and East Bank Demerara.

7. ARBITRATION PROCEEDINGS BEFORE THE INTERNATIONAL TRIBUNAL FOR THE LAW OF THE SEA

Mr. Raphael Trotman asked the Minister of Foreign Affairs the following question:

Can the Hon. Minister say what the cost of litigation is to date, and the estimated cost, of the Arbitration proceedings before the International Tribunal for the Law of the Sea, and how the Government intends to meet this cost? (Notice Paper No. 152 (Q89 Opp88) published on 2004-10-26)

Written reply submitted by the Minister of Foreign Affairs

It is not easy to answer this question at this early stage of the Arbitral proceedings before the International Tribunal for the Law of the Sea. In reply, I do not consider it to be in the national interest to go beyond reiterating what President Jagdeo said when speaking to reporters at the Office of the President on Friday, 2nd April, 2004 (as reported in Stabroek News of 3rd April, 2004), namely, that 'CGX Energy will help to pay Guyana's legal bills in seeking a solution to the maritime dispute with Suriname'. The President also said on that occasion that 'budgetary allocations would be made and he expects that the bulk of the bills will come due towards the end of the 3 year period' contemplated as the duration of the proceedings. I hope the Honourable Member will appreciate this response, given his own forensic experience and his understanding of the national interests of Guyana.

8. <u>GUYANA/SURINAME BOUNDARY ISSUE(S)</u>

Mr. Raphael Trotman asked the Minister of Foreign Affairs the following question:

What forms of third party involvement does the Government approve of to have the Guyana/Suriname boundary issue(s) resolved amicably and expeditiously? (Notice Paper No. 153 (Q90 Opp89) published on 2004-10-26)

Written reply submitted by the Minister of Foreign Affairs

It would be obvious to the Honourable Member, I believe, that the 'third party' involvement, of which the Government approves in seeking to resolve the maritime dispute with Suriname, is the one which it is pursuing. On our present assessment, recourse to arbitration under the ITLOS is the one most likely to resolve the Guyana/Suriname maritime boundary issue more expeditiously and with greater finality than any other.

I would like to remind the House of the Address to the nation by His Excellency the President on Wednesday, 25th February, 2004. In that Address, the President after indicating all the alternative avenues of settlement pursued by the Government and frustrated by Suriname, including third party mediation through CARICOM, said this: In these circumstances, the Government of Guyana has a clear and pressing duty to seek to resolve our maritime differences with Suriname by every peaceful means. Fortunately, as the Government of Barbados has recently demonstrated in its maritime dispute with Trinidad and Tabago, such means are at hand in the form of procedures available under the United Nations Convention on the Law of the Sea to which both Suriname and Guyana are Parties. These procedures allow for disputes relating to maritime boundaries between adjacent States which are Parties to the Treaty to be submitted for binding resolution to an Arbitral Tribunal established under the Treaty.

And His Excellency continued:

Everyone can be assured that we will proceed with the arbitral process with Suriname which we have initiated in the spirit of the United Nations Convention and in keeping with the highest standards of international amity - not as an adversarial process, but one designed to establish a sound basis for economic development in the maritime regions of both Suriname and Guyana. We hope the Government of Suriname will cooperate with us in achieving this.

That intention and that hope have characterized Guyana's approaches throughout.

As for other boundary issue outside the remit of the Arbitral Tribunal under UNCLOS, these currently remain within the mandate of the Joint Border Commissions. If this bilateral mechanism fails to produce a solution, third party involvement could conceivably be agreed upon by the parties through recourse to any of the meas for the peaceful settlement of disputes provides for in the United Nations Charter. The Government of Guyana will not foreclose any of its options, whether bilateral or multilateral, in seeking an amicable and expeditious resolution of its differences with Suriname.

Guyana is fully committed to the amicable and expeditious resolution of its boundary problems with Suriname.

Perhaps I should end this response by reminding the Honourable Member and the House of the penultimate paragraph of the President's Address:

Despite our differences on other matters, the political Parties of this country have always been united in matters affecting Guyana's territorial integrity. I look forward to us maintaining this tradition. On Monday we celebrated in unity the birth of our Republic; today let us go forward in unity strong in our resolve to stand together in defence of our territorial integrity under law under the law of Guyana, under the law of Nations.

That continues to represent the Government's hope and expectation.

9. <u>APPOINTMENT OF A PERMANENT REPRESENTATIVE TO THE UNITED</u> NATIONS

Mr. Raphael Trotman asked the Minister of Foreign Affairs the following question:

Can the Hon. Minister say why since his appointment as Minister of Foreign Affairs in 2001, a new Permanent Representative to the United Nations on behalf of Guyana has not been appointed; and if no hindrances exist, when such appointment will be made?

The position is currently being reviewed along with others in the Foreign Service. It is expected that it will soon be regularized with the postings planned for the New Year 2005.

10. GOVERNMENT'S POSITION AND STRATEGY VIS-A-VIS HAITI

Mr. Raphael Trotman asked the Minister of Foreign Affairs the following question:

What are the underpinning consideration that inform the Government's position and strategy vis-a-vis Haiti, and what is envisaged in terms of Guyana/Haiti and Haiti /CARICOM relations in the near future? (Notice Paper No. 155 (Q92 Opp91) published on 2004-10-26)

Written reply submitted by the Minister of Foreign Affairs

The Government of Guyana is concerned at the situation in Haiti, a sister CARICOM country, especially following the demission from office of President Aristide. In the eyes of the Government, the circumstances of the President's departure constituted an interruption of the democratic process in violation of the Inter-American Democratic Charter and CARICOM's Charter of Civil Society. Accordingly, along with other CARICOM states, Guyana had called for an impartial investigation of the circumstances of President Aristide's relinquishment of his office. Even though this investigation has not yet been conducted, Guyana has been working, within the CARICOM framework, for the early return of democratic government to Haiti, the peaceful stabilization of the country and significant humanitarian assistance to its people.

Following the deliberations of CARICOM Heads of Government on Haiti at their recently concluded Special Meeting in Trinidad and Tabago, it was reiterated that there could be no compromise on the fundamental principles of respect for human rights, due process and good governance enshrined in the CARICOM Charter of Civil Society. It was agreed that CARICOM would work with the Rio Group (on which CARICOM is represented by Guyana) and other interested parties to facilitate a dialogue among the political elements in Haiti, aimed at promoting inclusivity and reconciliation.

Guyana will continue to play its part to ensure the restoration of democratic government to Haiti and to bring relief to the suffering of the people from political violence and other forces.

AND WHEREAS Article 19 states that all Conventions, Recommendations and other Instruments adopted by the International Labour Conference must be submitted to the Competent Authority of members' states whether ratification of such Conventions is contemplated or not;

AND WHEREAS the submission of Conventions, Recommendations and other Instruments adopted at sessions of that Conference should always be accompanied or followed by a statement or proposal setting out the Government's view as to the action to be taken on the instruments;

AND WHEREAS the Government of Guyana, proposes to use the provisions of the Conventions, Recommendations and other Instruments adopted from time to time by the International Labour Conference as aims of policy and to ratify those Conventions which are in keeping with the social philosophy of the Guyanese society.
