# **UNPRECEDENTED FLOODING OF THE COASTAL AREAS**

Assembly resumed the debate on the following motion:

WHEREAS Guyana has recently witnessed an unprecedented amount of rainfall during the month of January with rainfall during the period December 24 to January 16 measuring in excess of 30 inches, the record amount for any similar period in the history of Guyana;

AND WHEREAS large areas of the coast in Administrative Regions 3, 4 and 5 have been inundated with the East Coast being the most severely affected;

AND WHEREAS as a result there has been incalculable personal and commercial damages suffered by thousands of households with many members being confined to their homes;

AND WHEREAS many of these households have been unable to access food, potable water and have been exposed to public health hazards, a consequence of which has been evacuation of homes, hospitalisations and fatalities;

AND WHEREAS Guyana now faces the worst natural disaster in its history;

AND WHEREAS the Guyanese people have rallied to the victims of the disaster in their thousands offering help in many ways;

AND WHEREAS religious bodies, private sector entities and organisations, trade unions, businesses, individuals and many others in Guyana and outside of Guyana have contributed and are continuing to contribute resources of various kinds to the relief effort and have pledged additional resources;

AND WHEREAS Guyanese and non-Guyanese organisations and overseas residents from many countries have pledged and donated goods and materials and have raised funds and continue to do so;

AND WHEREAS many Governments and international organisations have allocated or sent resources and assistance in many forms;

AND WHEREAS assistance and offers of assistance are continually being pledged by all of the above;

AND WHEREAS the Government has committed itself in partnership with specialised international agencies, to a comprehensive assessment of the impact of the disaster on the socioeconomic status of households, communities and national sectors devastated by the floods;

AND WHEREAS the Government intends to take action for the recovery and rehabilitation using the results of the assessment.

- 2. Expresses its gratitude to the people and organisations in Guyana and out of Guyana for the assistance they have given and continue to give;
- 3. Expresses its thanks to those Governments and international organisations which have contributed to the relief effort;
- 4. Urges all Guyanese and friends of Guyana to continue their efforts on behalf of the victims;

Include after Item 6 in the Be It Resolve Clause the following Item No. 7

Urges the Government in consultation with the political parties in the Parliamentary Opposition to appoint a Commission of Inquiry under the Commission of Inquiry Act, Cap. 19:03, to conduct a public inquiry into the likely causes of the recent unprecedented (abnormal) flooding of the coastal areas of Guyana and to make recommendations within three months of the establishment of the Commission.

The following amendment proposed by Mrs. Deborah Backer and seconded by Mr. Ivor Allen was <u>put</u> and <u>negatived</u>:

WHEREAS on the 16<sup>th</sup> day of November, 2004 Mr. Alan Munroe, Regional Chairman of Region 4 wrote the Honourable Harripersaud Nokta, Minister of Local Government and Regional Development a letter captioned 'FLOODING IN REGION #4 DURING THE UP-COMING RAINY SEASON';

<u>AND WHEREAS the aforesaid letter dated the 16<sup>th</sup> November, 2004 drew the Minister of</u> <u>Local Government and Regional Development attention to the fact "that there will be massive</u> flooding in Region # 4 during the up-coming season because of lack of funds to effect cleaning the <u>drainage system</u>";

<u>AND WHEREAS the aforesaid letter dated the 16<sup>th</sup> November, 2004 was copied to the</u> <u>Hounourable Samuel Hinds, M.P., Prime Minister; the Hounourable Satyadeow Sawh, M.P., Minister</u> <u>of Agriculture; The Hounourable Sasenarine Kowlessar M.P., Minister of Finance and Dr. Roger</u> <u>Luncheon, Head of the Presidential Secretaria;</u>

AND WHEREAS the coastal area of Guyana has recently witnessed an unprecedented amount of rainfall during the month of January, 2005 with rainfall during the period December, 2004 to January 16<sup>th</sup>, 2005 measured in excess of 30 inches, the record amount for any similar period in the <u>recorded</u> history of Guyana;

<u>AND WHEREAS as a result of the failure of Central Government to heed the advise of the</u> <u>Regional Chairman of Region #4; the unstable state of the East Demerara Water Conservancy Dam,</u> <u>the neglect by the Mayor and Councillors of the City of Georgetown of the drainage and irrigation</u> <u>of Georgetown and the unprecedented amount of rainfall between 24<sup>th</sup> December, 2004 to 16<sup>th</sup></u> <u>January, 2005 the City of Georgetown and the East Coast of Demerara were inundated with flood</u> <u>waters;</u>

<u>AND WHEREAS as a result of the poor condition of the Boeraserie Water Conservancy;</u> the poor conditions of several kokers and the unprecedented rainfall during the period 24<sup>th</sup> December, 2004 to 16<sup>th</sup> January, 2005 the West Bank of Demerara and parts of the West Coast of Demerara were inundated with flood water;

<u>AND WHEREAS to prevent the rice lands on the Essequibo Coast from being flooded, the</u> <u>Government took the decision to discharge the excess water from the Tapakuma Conservancy into</u> <u>the Pameroon River via the Arapiaco River and the Dredge Creek Canal thereby flooding farmlands</u> <u>throughout the Pomeroon damaging thousands of permanent and short term corps;</u>

<u>AND WHEREAS to prevent the collapse of the East Demerara Water Conservancy Dam,</u> <u>the Government took the decision to pump water into the Mahaica Creek, Mahaica, Mahaicony and</u> <u>the Cane Grove thereby flooding hundreds of houses along the Mahaica Creek, destroying in excess</u> <u>of 5,000 acres of rice together with acres of cash and permanent crops</u>; AND WHEREAS as a result there has been incalculable personal and commercial damages suffered by thousands of households with many persons confined to their homes;

AND WHEREAS many of these households have been unable to access food, potable water and have been exposed to public health hazards, a consequence o which has been evacuation of homes, hospitalizations and facilities;

AND WHEREAS Guyana now faces the worst disaster in its history;

AND WHEREAS the Guyanese people have rallied to the victims of the disaster in their thousands offering help in many ways;

AND WHEREAS religious bodies, private sector entities and organisations, <u>opposition parties</u>, trade unions, businesses, individuals and many others in Guyana and outside of Guyana have contributed and are continuing to contribute resources of various kinds to the relief and have pledged additional resources;

AND WHEREAS Guyanese and non-Guyanese organisations and overseas residents from many countries have pledged and donated goods and materials and have raised funds and continue to do so;

AND WHEREAS many Governments and international organisations have allocated or sent resources and assistance in many forms;

AND WHEREAS assistance and offers of assistance are continually beings pledged by all of the above;

AND WHEREAS the Government has committed itself in partnership with specialized international agencies to a comprehensive assessment of the impact of the disaster on the socioeconomic status of households, communities and national sectors devastated by the floods;

AND WHEREAS the Government intends to take action <u>to ensure that all citizens affected by</u> <u>the flood and effects of the flood receive compensation and are meaningfully rehabilitated.</u>

# BE IT RESOLVED:

That the National Assembly:-

- Expresses its deeply felt sadness and sympathy to the victims of the disaster;
- 2. Expresses its gratitude to the people and organisations in Guyana and out of Guyana for the assistance they have given and continue to give;
- Expresses its thanks to those Governments and International Organisations which have contributed to the relief effort;
- Urges all Guyanese and friends of Guyana to continue their efforts on behalf of the victims;
- 5. <u>Request the Government to establish a Commission of Inquiry to</u> <u>investigate the causes of the flooding, such Commission to present its</u> <u>report to the National Assembly by the 31<sup>st</sup> day of March, 2005;</u>

- 6. <u>Requests the Government to lay before the National Assembly by the</u> <u>31<sup>st</sup> day of March, 2005 a detailed time bound plan as to their short</u> <u>term, medium term and long term plans to preserve the integrity of the</u> <u>East Demerara Water Conservancy Dam;</u>
- 7. <u>Request the Government to lay before the National Assembly by the 31<sup>st</sup></u> <u>day of March, 2005 a detailed time bound plan as to their short,</u> <u>medium and long term plans to compensate and rehabilitate all persons</u> <u>affected by the floods;</u>
- 8. <u>Request the Government to lay before this Parliament by the 31<sup>st</sup> day</u> of March, 2005 a detailed time bound plan which will ensure that the farmers of the Mahaica Creek and adjacent areas are not flooded <u>annually</u>;
- <u>Request Government to lay before this National Assembly by the 30<sup>th</sup></u> <u>day of June, 2005 a detailed Disaster Preparedness Plan;</u>
- Support the efforts of the Government of Guyana, the Opposition and all other political organisations, which have contributed, to the relief efforts;
- 11. Urge the people of Guyana, including the victims of the flood, to continue their valiant and courageous struggle against this disaster.
