Funeral for the Late Rev. Dr. Dale Bisnauth

"Members are reminded that the funeral of the late Member of this August House, Dr. Dale Bisnauth is at 10.00 a.m. tomorrow at Burns Memorial Church which is in Irving and Anira Streets.

There is going to be cremation thereafter, at Good Hope Crematorium and I have discussed with the Whips and we have agreed that we will commence tomorrow's Sitting at 2.00 p.m. to allow Members of the House who wish to attend the funeral and perhaps the cremation to do so without any let or hindrance."

Death of Pandit Reepu Daman Persaud, O.R., J.P.

"The second announcement is on again a very sad note, that is, not to announce but mark the death of Mr. Reepu Daman Persaud, O.R., Justice of the Peace (JP) who we learnt died early in the morning on the 7th April at the Georgetown Public Hospital Corporation. Pandit as he was known served in this house; first known as a House of Assembly - from 1964 to 1966 and it was on the 31st December 1964 that Parliament recalled and had its first meeting and it was on the 18th May, 1965 that Pandit Persaud took the oath of office and became a Parliamentarian.

After Guyana gain Independence on the 26th May, 1966 he was named as a Member of Parliament in the First Parliament which lasted from 1966 to 1968. He was also a Member of the Second Parliament from 1969 to 1973 and took the oath of office for the Third Parliament on the 24th May, 1973, which lasted from 1973 and remained there until 1980. Mr. Persaud was designated a minority Chief Whip during the fourth Parliament which was from 1980 to 1985 and designated Deputy Speaker of this National Assembly in the Fifth Parliament from 1985 to 1992. In 1992, Mr. Persaud was designated Senior Minister of Agriculture in the Sixth Parliament from 1992 to 1997 and during the Seventh Parliament which lasted from 1997 to 2001, Mr. Persaud was again designated Senior Minister of Agriculture and later in that said Parliament he was given responsibilities for Parliamentary Affairs.

In the Eighth Parliament, spanning from 2001 to 2006, Mr. Persaud was designated Minister of Parliamentary Affairs. Our former colleague also served as Chairperson of the Public Accounts Committee from 1968 to 1974.

On a more personal note, I would like to say that I first got to know Pandit Reepu Daman Persaud in the Seventh Parliament and had good experience working alongside him on many critical matters that occupied our time and attention in those days, such as political dialogue between the parties to resolve differences and constitutional and parliamentary reforms. In Pandit Reepu Daman Persaud, I found an astute sometimes wily, but always formidable Politician. He was the epitome of the gentleman parliamentarian who was always gracious, respectful and extremely knowledgeable of the Constitution and Standing Orders of the National Assembly. To those who seek to uphold the Westminster type tradition of parliamentarianism, the Hon. Reepu Daman Persaud I thought was the best example I could offer.

He had style and panache and I believed that only once in the many years that I came up against him, that I saw him losing his calm and collective demeanor. He characterised the way we ought to practice politics in this Chamber and that is with decorum and dignity. I am extremely happy that in 2012, this National Assembly was able to recognised and honour the Hon. Reepu Daman Persaud for his long and outstanding contribution to the democracy of Guyana and it is always better I think to say thank you to someone in life than posthumously in death and so I leave the Chamber with the words of the Poet Rabindranath Tagore:

"Death has not extinguishing the light, it is only putting out the lamp as the dawn has come".
