#### **ANNOUNCEMENTS BY THE SPEAKER**

The Speaker made the following announcements:

#### **Ambulance Facility**

"The announcements are first being that some of you or most of you would have noticed an ambulance in the compound. It is nothing to be exceptionally alarmed about. It is just as a

precaution in keeping with the undertaking given by the Parliament Office to have every facility available. #### Resignation of Mr. Richard Allen, M.P.

"On a more serious note, Hon. Members, this morning I received a letter from Mr. Richard Allen informing me that he was resigning his seat a Member of Parliament with effect from the 5<sup>th</sup> April 2013. Mr. Allen's resignation therefore means that his seat in this National Assembly has become vacant.

The vacancy, in accordance with Section 99A of the Representation of the People Act, Chapter 103 of the Laws of Guyana, is to be filled by a person whose name is to be extracted from the list of candidates from which Mr. Allen's name was originally extracted. Mr. Allen's name was extracted from A Partnership of National Unity's list of candidates. I have, in accordance with Section 99A of the said Act, called upon the representatives of that said list to further extract from that list the name of a person who is willing to become a Member of this National Assembly to fill the vacancy in the Assembly."

At 10.00 p.m., on a motion by the Prime Minister and Minister of Parliamentary Affairs, Standing Orders No. 10(1) was suspended to enable the Assembly to continue with the budget debate uninterrupted.

#### **CONCLUSION OF BUDGET DEBATE**

Following the conclusion of the general debate on the motion for the approval of the Estimates of Expenditure for the financial year 2013, Assembly resolved itself into Committee of Supply to consider and dispose of the Report of the Business Sub-Committee of the Committee of Supply.

#### **In Committee of Supply**

The Speaker reported that the Business Sub-Committee of the Committee of Supply met on Tuesday, 9<sup>th</sup> April, 2013, and considered proposals (with Schedules) from the Government and Opposition, respectively, for the consideration of the Estimates of Expenditure for 2013.

The Opposition's proposal, which was moved by Mr. Carl B. Greenidge, M.P., and seconded by Mr. Khemraj Ramjattan, M.P., was passed by a majority vote.

The Government's proposal, which was moved by the Minister of Finance and seconded by the Minister of Housing and Water, was also considered and negatived by a majority vote.

The Sub-Committee agreed that the proposals (with Schedules submitted) by the Government and Opposition should be reported to the Committee of Supply and printed and circulated with the Minutes of the Proceedings.

It was noted that the Sub-Committee's Minutes, Resolution and Schedule submitted by the Opposition were circulated to Members at the sitting of the National Assembly on Tuesday, 9<sup>th</sup> April, 2013.

The Speaker further reported that the Sub-Committee had agreed that the date of the commencement of the consideration of the Estimates of Expenditure for 2013, should be decided by the National Assembly.

The Minister of Finance informed the Assembly that the Government was not in agreement with the Resolution of the Business Sub-Committee and, as such, had submitted a Minority Report (with Schedule attached) of the Business Sub-Committee.

Thereafter, the Report of the Business Sub-Committee (with Schedule submitted by the Opposition) was put and negatived on the following division:
