#### ANNOUNCEMENTS BY THE SPEAKER

The Speaker made the following announcements:-

#### (i) Death of a former Minister of Government

"Hon. Members a former Member of this House and Minister of Government, Mr. Shiv Sahai Naraine, who held the Cacique Crown of Honour, died after a brief illness in Canada on the 30<sup>th</sup> July this year. He was 89 years old. Mr. Naraine first served as a Legislator from 1<sup>st</sup> August, 1972 until the 23<sup>rd</sup> July, 1973 and as Minister of Public Works and Housing from 24<sup>th</sup> July, 1973 to 31<sup>st</sup> December 1980, at which time he was appointed Senior Minister of Works and Transport. From 1<sup>st</sup> January 1981 to 14<sup>th</sup> October, 1983 Mr. Naraine was Vice President and Minister of Works and Transport. On the 14<sup>th</sup> October, 1983 Mr. Naraine tendered his resignation as a Member of the National Assembly. On the 15<sup>th</sup> October, 1983 Mr. Naraine was designated Guyana's High Commissioner to New Delhi, India, a post he held up until 14<sup>th</sup> July, 1990.

Hon. Members, I now ask that you stand with me as we observe one minute silent as a mark of respect for the late Shiv Sahai Naraine."

#### (iii) Upgrading of facilities

"During the recess, which commences as we know on the 10<sup>th</sup> August, the entire roof of the Assembly will be restored. Thanks to the Ministry of Public Works for collaborating with us. It is leaking.

Also the washroom area, particularly, that of females, will be extended and upgraded to include a new washing area. There will also be separate washroom facilities for the members of the public and the press.

The parapet in front of the Public Buildings, which has been badly damaged by the vehicles using it as a park at nights and for other occasions, will be restored. Again, thanks to the Ministry of Public Works, working in collaboration with us. On the right side of the compound, within the compound will be made into a car park, for more parking, for Members of Parliament because parking immediately outside will be restricted.

Also the air conditioning units will be replaced in the Chamber. Members who had raised concerns early last year about security, a security scanner will be installed for use by all, that would have meant Members of Parliament and members of the public who wish to access the building particularly on days of sittings. There will be an electronic scanner through which we all shall have to submit and subject ourselves."

1. AGREEMENT/CONTRACT BETWEEN THE GOVERNMENT OF GUYANA AND TELEVISION GUYANA INC.(TVG)

**Member Asking:** Mrs. Catherine Hughes, M.P.

#### **Minister Answering:** The Minister of Education

- (i) Can the Hon. Minister provide copies of the Agreement/Contract between the Government of Guyana and Television Guyana Inc. (TVG) for the use of TVG's teleport/transmission facilities to broadcast the Learning Channel?
- (ii) Can the Hon. Minister state when the tender for the provision of this service was advertised and in which media?
- (iii) How much money has been paid over to Television Guyana Inc. (TVG) to date for the provision of these services?
- (iv) What is the duration of this contract/contractual arrangement yearly, monthly or indefinite?
- (v) How many persons are employed by the Learning Channel and from which communities are they?
- (vi) Does the Learning Channel (the Company) possess its own satellite receivers/dishes?
  - (a) If yes, in which geographical location/communities are they located?

- (b) If yes, when were these purchased? From whom were they purchase and at what cost? Would the Hon. Minister provide copies of such Purchase Agreements?
- (vii) How many antennas does the Learning Channel utilise and in what geographical areas?
- (viii) In what geographical areas does the Learning Channel utilise the equipment of Digicel, GT&T or any other network for the broadcast of its programming?

#### **Answers:**

"The Hon. Minister of Education wishes to state that the subject of the establishment of the Guyana Learning Channel, its existence now, its plan for sustenance and expansion and its relationship with Television Guyana (TVG), were all matters that were extensively dealt with at a press conference hosted by the Ministry of Education on or around 24<sup>th</sup> April, 2013 at the National Centre for Resource Development, Kingston, Georgetown. Indeed, all of the questions hereunder were answered either in the opening statements made or by way of answers provided to questions asked by the various media houses. This press conference was widely covered and its contents published by all of the reputable media houses.

A copy of the statement made at the said press conference by Dr. Seeta Roath, the Head of the Multi Media Unit/Guyana Learning Channel is hereto attached and marked "PC 1". A copy of the bullet pointed brief of the said statement issued to the press is also hereto attached and marked "PC 2". (See Appendix)

(i) "The Hon. Minister is happy to provide same. A copy of the contract is attached. (See Appendix)

(ii) The Minister has been advised that TVG was at the time of the procurement of the service, and remains now, the only supplier of this service which allows communities all across this country to be able to benefit from the programs on the Learning Channel and that no other reasonable alternative or substitute exists. The Minister would be happy to be advised if, contrary to advice, the Honourable member asking this question is aware of the existence of any other supplier of the same service with the same specifications that would allow for the same quality of service to reach the sons and daughters of Guyana.

The service entity may engage in single-source procurement under the Procurement Act of 2003 to wit, section 28(a) which states as follows:-

"the goods or construction are available only from a particular supplier or contractor, or a particular supplier or contractor has exclusive rights with respect to the goods or construction, and no reasonable alternative or substitute exists."

- (iii) As per abovementioned contract, the sum of \$3 million per month from December, 2011 – present has been paid to TVG for their service which TVG has been, as per contract, providing.
- (iv) The contract was entered into in 2010 for a period of five years.
- (v) Six full time, six part-time and two temporary persons are employed at the Learning Channel. All others, such as studio teachers and scriptwriters, are contracted as needed. The Learning Channel hires the best skill available for the best price available. Decisions to hire are not based upon any other consideration such as ethnicity, community from which persons have emanated, gender, social background,

class etc., and it is hoped that the basis for this question was not for purposes of profiling any of the persons employed by that entity. The persons presently employed are from Georgetown, New Amsterdam, Orealla and Kwakani.

(vi) Yes, the Learning Channel owns its own satellite receivers/dishes. They are located in Georgetown, New Amsterdam, Benab, Orealla, Kwakwani, Linden, Lethem, Annai, Aishalton, Mahdia, Port Kaituma, Mabarauma, Bartica, Morakaibai, Anna Regina, Karasabai and Ituni. It is because of the said satellite receivers/dishes that the residents of said community are able to receive the programs shown on the said channel.

These items were purchased from TVG. The items purchased were 17 antennas, 20 dishes, 17 receivers and 16 dish stands along with the service to install of all of these at the price of \$6.987M.

- (vii) The Learning Channel owns and utilizes 17 Antennas. They were located in Georgetown, New Amsterdam, Benab, Orealla, Kwakwani, Linden, Lethem, Annai, Aishalton, Mahdia, Port Kaituma, Mabarauma, Barticak, Anna Regina, Karasabai and Ituni.
- (viii) The Guyana Learning Channel utilizes the Tower of GT&T at Benab and the Tower of Digicel at Moria Point."

#### 3. NATIONAL GRADE SIX ASSESSMENT

Member Asking: Ms Amna Ally, M.P.,

**Opposition Chief Whip** 

#### **Minister Answering:** The Minister of Education

- (i) Could the Hon. Minister present in a written form the analysis of the National Grade Six Assessment for all the regions in Guyana?
- (ii) (a) Could the Hon. Minister give an overall percentage of pupils who fell below the pass marks in Mathematics, Science, English and Social Studies?
  - (b) How many students fell below 400 marks?
- (iii) Could the Hon. Minister state whether the results of the Grades 2 and 4 Assessment were included in the final Grade 6 Assessment in all cases?
- (iv) (a) Could the Hon. Minister indicate whether there were requests in 2012 for reviews of the NGSA exam results? If so, how many and were these reviews done?
  - (b) Could the Hon. Minister tell this National Assembly whether there were requests for reviews of the National Grade Six Assessment in 2013? If so, how many and when will these reviews be completed?

#### **Answers**:

"The National Grade Six Assessment 2013 was written on the 25 & 26 March 2013 across all ten (10) administrative regions of Guyana. Sixteen thousand eight hundred and eleven (16,811) candidates were entered for the assessment. Ninety eight (98%) percent of the students entered wrote the assessment. The candidates also wrote the National Grade Two Assessment (NGTA) in 2009 and National Grade Four Assessment (NGFA) in 2011. The results of the National Grade Six Assessment present a candidate's overall performance at three assessments.

The highest possible standardize score obtainable in Mathematics – 134, English – 146, Social Studies – 138, and Science-142. The highest possible total score obtainable was 560.

Note: For logistical and analytical purposes, Georgetown is disaggregated from Region # 4 and is referred to as Region # 11.

The largest number of candidates for the National Grade Six Assessment were from Region # 4 (Demerara-Mahaica) with 3556, followed by Georgetown with 2850 and Region # 3 (Essequibo Islands-West Demerara) with 2213. The smallest number of candidates being presented were from Region # 8 (Potaro-Siparuni) with 282 candidates.

Georgetown secured the highest percentage of candidates obtaining 50% and more in all four subject areas, Mathematics – 58.11%, English Language -43.19%, Science-43.51% and Social-Studies-58.18%. Region # 10 (Upper Demerara- Berbice) followed with 51.05% in Mathematics, English - 34.94%, Science-40.79% and Social Studies – 52.5%. Region # 3 was third in candidates receiving 50% and more in all four subject areas, with Mathematics – 48.76%, English - 31.95%, Science - 35.65% and Social Studies - 47.99%. Region # 8 and Region # 1 secured the lowest percentage of candidates obtaining 50% and more in the four subject areas.

(i) The norm reference test is the type of assessment or evaluation which yields an estimate of the position of the tested individual in a specific population, therefore the highest possible score by a candidate one year can be 555 marks and in another year 548 marks. The National Grade Six Assessment utilizes the norm-reference type of testing and is specifically geared at the placement of students into the secondary level.

In 2013 43.9% of the candidates scored over 50% in Mathematics, 28.7% scored over 50% in English 31.8% scored over 50% in Science and 44% scored over 50% in Social Studies.

Please note that significant improvements were recorded over the years as can be seen from the table below.

<sup>(</sup>ii) The results for the National Grade Six Assessment are presented using standardized scores therefore 400 marks cannot be use as a bench mark for pass or failure.

It should be noted that marks gained at the National Grade Six Assessment might not place a candidate at a List A school in Georgetown, but place another candidate with the same score in a List A school in another Region. 9,040 students scored below 400 marks.

(iii) The National Grade Two Assessment 2009 and National Grade Four Assessment 2011 were added to the National Grade Six Assessment 2013 scores. A percentage of the marks gained at the Grade Two and the Grade Four Assessments was combined with the marks gained at the Grade Six Assessment in order to determine the candidates' overall scores. Five percent (5%) of each candidate's Grade Two score in Mathematics and English, and ten percent (10%) of the Grade Four score in the same subjects, were added to eighty five percent (85%) of each candidate's score in those subjects. The combined scores in Mathematics and English were added to the scores gained in Science and Social Studies.

It should be noted that candidate 6047--- was awarded a place at Tutorial Academy and candidate 11102--- was placed at Queen's College.

(iv) Examinations Division, Ministry of Education, entertains reviews for the National Grade Six Assessment on an annual basis. A letter indicating a request for a review must be forwarded from the Headteacher of the Primary school to the Examinations Division along with a review fee. Acceptance of reviews closes three weeks after the release of the NGSA results. If there are any changes to the results the review fee is refunded.

In 2012 there were sixty seven (67) requests for reviews and all were completed.

(v) In 2013 there were 86 requests for reviews and all were completed.

"The contract was signed on October 29, 2012 and the project duration was expected to be for 6

months. The actual start date was February, 2013 and there was a period of unforeseen delays for

about 3-4 weeks with a defects liability period for 3 months

The contractor did not commence the works promptly after signing the contract in October 2012

since the Regional Administration was unable to identify alternative locations for the students

and teachers. It was only until the end of January 2013 the Regional Administration indicated

that they were successful in relocating the students. The contractor was then allowed access to

the site and hence commenced the works during the second week of February 2013.

On March 18, 2013 a letter from the REO was sent to the Permanent Secretary, MOE

highlighting issues identified by the building overseer Mr. D. Ram. Consequently, a site visit was

made by the Ministry's engineer who confirmed that the Bill of Quantities was deficient.

As a result, the entire Bill of Quantities was reviewed and re-designed. The contractor was asked

to stop working for a period of 3-4 weeks during this review.

The Contractor is adamant that he will complete the entire project by the end of September

2013."

They were advised to apply for the positions after which an interview would be done and forwarded to the Teaching Service Commission."

community will benefit from increased hours of service. This project is scheduled to be

completed by the end of 2013."

- (ii) No vessel takes thirty-six (36) hours to reach Mabaruma the vessel takes approximately twenty-five (25) hours. Discharging of cargo enroute at Morawhanna and the inclement weather conditions recently has occasionally added delay time.
- (iii) Currently there is no consideration to assign another ferry to ply the Mabaruma District. However, the M.V. Kimbia which is in dock and which plies this route is slated to be out of dock by August 15, 2013.

There has been a decision to acquire a new modern vessel for the Region #1 service, so as to upgrade the comfort, reduce time and improve serviceability on this route.

The new vessel is intended to be in service in 2014."

The Scope of works was re-examined and approved by the National Procurement and Tender Administration Board on the 22nd of August, 2012 and the contractor was advised. Works commenced on 16<sup>th</sup> September with a contract duration period of Six (6) months (16<sup>th</sup> March, 2013 projected completion date), additional changes were made due to the boggy nature of the land which now caters for a long term effect with the installation of a Revetment at the Sides and front catering for the most vulnerable and traffic traversing areas of the Tarmac with longer(from 8 to 10ft) driven piles and more backfilling and as such approval was again granted as per directions of the Supervising Engineer and the Ministry of Local Government and Regional Development this created another 3 months extension which now takes effect to August of 2013.

The back of the Tarmac was excluded due to plans for future expansions which have now taken effect since award was made as part of 2013 budget estimates.

#### Clause 2

The Prime Minister and Minister of Parliamentary Affairs moved the following amendments, which were <u>put</u> and <u>carried</u>:

"Clause 2 - For the words beginning with "for" and ending with "facilities" substitute the following –

"for the management, conservation and preservation of the environment surrounding hydroelectricity generating facilities or areas intended as compensation for residual impacts from hydroelectricity generating facilities"."

Clause 2 was then <u>passed</u> as <u>amended</u>.

#### Clause 3

The Prime Minister and Minister of Parliamentary Affairs moved the following amendments, which were <u>put</u> and <u>carried</u>:

"Renumber clause 3 as clause 6 and insert the following as clause 3 –

- 3. Section 2 of the Principal Act is amended
  - (a) by the insertion immediately after paragraph (vi) in the definition of "undertaking" of the following paragraph as paragraph (viA) –

"(viA) the taking of all appropriate measures for the management, conservation and preservation of the environment, flora, fauna, aquatic life and ecological habitat of areas surrounding hydroelectricity generating facilities or areas intended as compensation for residual impacts from hydroelectricity generating facilities;";

- (b) by the insertion in the definition of "water-power" immediately after the words "commercial value" of the words "and in a manner consistent with the conservation and preservation of the environment surrounding hydroelectricity generating facilities or areas intended as compensation for residual impacts from hydroelectricity generating facilities";
- (c) by the insertion in the definition of "works" immediately after the words "electrical energy" the words "and any measures taken for the management, conservation and preservation of the environment surrounding hydroelectricity generating facilities or areas intended as compensation for residual impacts from hydroelectricity generating facilities";
- (d) by the insertion immediately before the definition of "divert" of the following definition –

"biodiversity offset" means measurable conservation outcomes resulting from actions designed to compensate for significant residual adverse biodiversity impacts arising from project development, and persisting after appropriate prevention and mitigation have been taken with the goal to achieve no net loss and preferably a net gain of biodiversity on the ground with respect to species composition, habitat structure, ecosystem function and people's use and cultural values associated with biodiversity;";

(e) by the insertion immediately after the definition of "Engineer" of the following definition –

"hydroelectric offset reserve area" means the identified portions of land and water set aside by reason of their physical and biological values, ecosystem function, to be managed to enhance biological diversity, sustenance, people's use and cultural value, habitat structure and protect against negative anthropogenic impact;";

(f) by the insertion immediately before the definition of "water-power" of the following definition –

"watershed" means the area or region drained by a river, river system, or other body of water;".

Clause 3 was then passed as amended.

#### Clause 4

The Prime Minister and Minister of Parliamentary Affairs moved the following amendments, which were <u>put</u> and <u>carried</u>:

"Insert the following as clause 4 –

1. Section 6 of the Principal Act is amended in subsection (1) by the substitution for the full stop at the end of paragraph (c) of a colon and by the insertion after the colon of the following words -

"Provided that such licence shall be granted subject to the taking of all appropriate measures for the conservation and preservation of the environment, flora, fauna, aquatic life and ecological habitat of areas surrounding hydroelectricity generating facilities."". Clause 4 was then <u>passed</u> as <u>amended</u>.

#### Clause 5

The Prime Minister and Minister of Parliamentary Affairs moved the following amendments, which were <u>put</u> and <u>carried</u>:

"Insert the following as clause 5 –

- 1. Section 12 of the Principal Act is amended by the insertion immediately after paragraph (h) of the following as paragraph (i)
  - "(i) failure by the licensee to take all appropriate measures for the conservation and preservation of the environment, flora, fauna, aquatic life and ecological habitat of areas surrounding hydroelectricity generating facilities."

Clause 5 was then <u>passed</u> as <u>amended</u>.

#### Clause 6

The Prime Minister and Minister of Parliamentary Affairs moved the following amendments, which were put and carried:

"Section 23 of the Principal Act is amended as follows –

- (a) in section (1) by inserting immediately after paragraph (o) the following paragraph as paragraph (oA)
  - "(oA) the establishment of a hydroelectric offset area authority or similar authorities, the creation of hydroelectric offset areas and rules for the establishment, management and operation of hydroelectric offset reserve areas for the conservation and preservation of the environment surrounding hydroelectricity generating facilities;"

(b) in subsection (2) by the substitution for the words "nineteen thousand five hundred dollars" of the words "one million dollars"."

Clause 6 was then <u>passed</u> as <u>amended</u>.

#### Clause 7

The Prime Minister and Minister of Parliamentary Affairs moved the following amendments:

"Insert the following as clause 7 –

Section 26 of the Principal Act is amended –

- (a) by the renumbering of section 26 as section 26 (1);
- (b) by the substitution for the words "of four hundred dollars" of the words "not exceeding ten million dollars";
- (c) by the insertion of the following as subsections (2), (3), (4) (5) and (6)–
  - "(2) The following acts are prohibited within hydroelectric offset reserve areas—
    - (a) mining, mineral locating, logging, farming and agricultural activity of any kind;
    - (b) hunting, destroying, disturbing, or mere possession of any plants or animals or products except by indigenous peoples for traditional use;
    - (c) dumping of any waste products detrimental to the hydroelectric offset reserve area, or to the plants and animals or inhabitants therein;
    - (d) mutilating, defacing or destroying objects of natural beauty, or objects of interest to cultural communities of scenic value;

- (e) damaging and leaving roads and trails in a damaged condition;
- (f) squatting, adverse possession or opportunistic settlement or otherwise occupying any land;
- (g) constructing or maintaining any kind of structure, fence or enclosure;
- (h) leaving in exposed or unsanitary conditions refuse or debris, or depositing in ground or in bodies of water;
- (i) altering, removing destroying or defacing boundary marks or signs; and
- (j) any other acts so designated by the Minister on the advice of the competent Hydroelectric Offset Area Authority, or any other act prohibited to satisfy obligations of the State under local or international law.
- (3) Anyone who commits any of the acts in subsection (2) (a) to (j) commits an offence and shall be liable on summary conviction to a fine not exceeding ten million dollars.
- (4) The Minister on the advice of the competent Hydroelectric Offset Area Authority may by regulations
  - (a) amend the list of offences in subsections (2) (a) to (j) for actions that contravene the objectives of this Act and the Hydroelectricity Offset Reserve Area Regulations made under it:
  - (b) fix the amount of the fine for a prescribed offence, but the amount shall not exceed ten million dollars.

- (5) All new offences shall be gazetted and published weekly in a national newspaper of wide circulation for no less than three consecutive weeks.
- (6) No person shall be liable for any newly created offence until three months after the last date of its publication in the Gazette.".

# ITEM 8 - LIMIT ON AMOUNT OUTSTANDING UNDER GUARANTEES GIVEN UNDER THE GUARANTEE OF LOANS (PUBLIC CORPORATIONS AND COMPANIES) ACT

The Minister of Finance moved the following motion:

WHEREAS in accordance with Section 3(1) of the Guarantee of Loans (Public Corporations and Companies) Act, Chapter 77:01, the Government may in such manner and on such terms and subject to such conditions as may be agreed between it and a lending agency –

- (a) Guarantee the discharge by a Corporation of its obligations under any agreement which may be entered into by the Corporation with a lending agency in respect of any borrowing by that Corporation that is authorised by the Government;
- (b) Assume such other obligation as may be agreed between the Government and a lending agency in relation to or pursuant to any such agreement;
- (c) Undertake the repayment to a lending agency of such sums as the lending agency may have advanced to or for the benefit of the Government;

AND WHEREAS it is provided under Section 2(2) of the aforesaid Act that, for the purposes of the Act, a borrowing by a Corporation shall be deemed to include the obligation of the Corporation to make payments to any person arising out of any contract lawfully entered into by the Corporation;

AND WHEREAS it is provided under Section 4(1) of the aforesaid Act that the aggregate amount of the liability of the Government in respect of guarantees given under Section 3 of the Act shall not at any time exceed the sum of one thousand million dollars or such greater sum as may from time to time be specified by the Resolution of the National Assembly;

AND WHEREAS it has become necessary to specify in accordance with the said Section 4(1) a greater sum for the purpose of enabling the aggregate amount of the liability of the Government in respect of guarantees to be increased due to the extended activities of those incorporated bodies to which the Act applies in accordance with the country's development progoramme,

#### BE IT RESOLVED:

That this National Assembly approve that the aggregate amount of the liability of the Government under Section 4(1) of the Guarantee of Loans (Public Corporations and Companies) Act, in respect of guarantees given under Section 3 of the Act, shall not at any time exceed the sum of one hundred and fifty thousand million dollars.
