"There are two (2) District Development Officers stationed in the North Pakaraimas, based at Monkey Mountain and Kurukubaru Villages. These officers have jurisdiction for the villages of:

- Monkey Mountain
- Taruka
- Tuseneng
- Bamboo Creek
- Kurukubaru
- Kopinang

These officers were appointed in October, 2012 and December, 2012. The job description of these officers includes:

Purpose:

Ensure that local authorities function within the various Acts and Regulations and that licence revenue is properly assessed for business.

Key Outputs:

- Properly accounted for revenue and expenditure of Local Authorities.
- Estimates of Revenue and Expenditure of local authorities presented as per requirement.
- Licensed premises.
- Adequately prosecute defaulting Businesses.
- Fairly assessed scales and weights.

Range of Activities

- Examine all vouchers from local authorities and certifies payments.
- Certifies ledger entries and advises local authority balances.
- Certifies revenue collections from local authorities and sign cheques for local authorities.
- Examine and certifies revenue and expenditure cash books and draft estimates from all local authorities.
- Check cash received from licence sales on a daily basis and certifies cash book.
- The preparation and submission of fortnightly and monthly revenue statement from licence sales to Commissioner of Inland revenue.
- Visit new business premises to determine value of licence.

- Conduct visits on business premises to check licence, scales, weights and measures.
- Prepare summons to defaulting business persons and attend court to assist prosecution.

Nature and Scope

Qualification, Knowledge and Experience.

Diploma in Public Administration or Accountancy from recognized University or four subjects GCE/CXC or other equivalent qualification plus eight years experience in accounting work at least five of which must be in the Local Government Section.

Decision Making, Problem Solving, and Impact on Results;

The post holder is assisted in decision making using the Act and Regulations as guides. He is expected to use judgment in the granting of Licenses. Failure to asses business accurately can result in embarrassment to the authorities.

Resource Management;

The post holder supervises a minimum of five (5) persons and is responsible for office equipment. He is not a budget holder.

Communication:

Communicates regularly with the Assistant Regional Executive Officer and Deputy Regional Executive Officer (Development) and Executive of Local Authorities and staff. Must also communicate with other Senior Regional Officials and members of the Public from time to time.

Working Conditions;

Office and Field Travels extensively within the Region In interior Regions the DDO represents the REO at the District Levels.

The DDO monitors movement of Coast Landers within Amerindian Communities and ensures ejection in the absence of the legitimate permission for the Ministry of Local Government.

The DDO operates Sub Imprest at district offices which they surrender before December 15 of each year.

Offer advice where necessary, to Amerindian Councils. Effect payment to staff in the District area, but not in all instances.

Further, DDOs are required to document all issues relating to Health, Education, Administration and Public Works that affect Hinterland Communities and offer possible solution to these issues."

2. <u>PERMETHRIN-TREATED BED NETS</u>

Answer:

"INTRODUCTION

Malaria and certain other diseases are transmitted by the bite of mosquitoes. Pregnant women, babies and young children are at the greatest risk of dying of malaria. Sleeping under a bed net reduces the risk of man-vector contact as mosquitoes bite at night and is thus an effective preventive measure. But ordinary mosquito nets provide limited physical barrier between mosquito and man and protection as they may still bite through the net or get inside the net following improper use. The Insecticide Treated Bednets (ITNs) or Long Lasting Impregnated Bednets (LLINs) provide better and effective protection by keeping away mosquitoes as well as killing them. ITNs and LLINs also kills or keeps away other nuisance insects like cockroaches, bedbugs, houseflies, fleas, etc

LONG LASTING INSECTICIDAL NETS (LLINS)

LLINs are mosquito nets which have the insecticide incorporated in their fibre, so that it is not removed by as many as 20 washes. Because these nets have an even and quality controlled insecticide application, they are generally more effective than conventional ITNs. Furthermore the LLIN is more cost-effective (as it can be used for 3-5 years) than distribution of conventional bed nets and treating them with insecticide once or twice a year. Conventional ITNs are therefore only a rational option in areas, where the population already has so many nets that at least 50% of people sleep under one.

Re-treatment of LLINs is not necessary at this time as we will consider doing this in two to four years from now depending on the need. However when this need arises we are fully capable of doing so.

4. PROVISION OF DOMESTIC WATER SUPPLIES – VILLAGES IN REGION # 8

Member Asking: Mr. Ronald Bulkan, M.P.

Minister Answering: The Minister of Housing and Water

- (i) Can the Hon. Minister provide the National Assembly with the current plan for providing and maintaining domestic water supplies through wells and standpipes in Region # 8, especially the villages in the Pakaraimas?
- (ii) Detail village-by-village, how this plan and the associated actions by Guyana Water Inc. addresses the needs of the rising population in these villages since December, 2011?
- (iii) Detail the training programme for Region # 8 since December, 2011 so that all villages learn how to maintain and repair their water supplies?

Answers:

"(i) The current plan for providing and maintaining domestic water supplies in the Region 8 communities is attached (See Appendix). It is targeted under the strategic plan (2012-2016) for 80% coverage to be achieved in the Hinterland communities. As can be seen on the plan, works were undertaken prior to 2011 and in 2012 and another project is scheduled for completion in 2013 (Bamboo Creek). The maintenance of the systems are usually done by the communities, who would have received training on managing and maintaining such system. GWI provides technical support upon the request of the communities.

- (ii) As can be seen on the plan, projects are undertaken progressively as the villages are assessed and based on the water resources in the area. Assessment are scheduled to be undertaken of the areas without main facilities and based on the resources projects will be developed. It should be noted that challenges have been encountered in the drilling of medium depth wells due to challenging hydro geological formation in these locations.
 - (iii) The training programme of GWI entails training the villages to manage and maintain the systems before hand over. In addition, training is usually done when GWI visits the communities upon the request of the villages to assist to solve any problem."
