This is just a part of those arrangements.

In keeping with our honouring of this great man, I have asked and the Clerk has ensured that the three flags flying over this building are being flown today, at half mass in recognition of the death of this great man. I am told that a formal motion to give due recognition to the contribution of this President and former Great States' Man of the world who worked to strengthen world peace and understanding between people will be tabled and debated in the House very shortly. I have been given this assurance by Members of both Government and Opposition."
