ANNOUNCEMENTS BY THE SPEAKER

(i) Visit of Delegation from National People's Congress of People's Republic of China

The Speaker invited the attention of Members to the presence at the sitting of a Delegation from the National People's Congress of the People's Republic of China.

The Speaker stated that the Delegation was headed by Her Excellency Madame Chen Mu Hua, Vice Chairperson of the Standing Committee of the National People's Congress, and comprised of three other persons from the Congress and some supporting staff. A full list of the Members of the Delegation including some biographical data on Madame Chen was circulated to Members of the Assembly. Madame Chen is the highest ranking female Party and Government functionary of the People's Republic of China.

The Delegation arrived in Guyana on 30th June, 1993 as part of a Caribbean tour which included Mexico, Barbados and Suriname.

The Speaker, on behalf of the National Assembly, extended a warm welcome to Madame Chen and the other Members and Officials of her Delegation, and wished them a pleasant and successful stay in Guyana.

While in Guyana, the Delegation would familiarizing themselves with the aspects of Guyanese cultural life and activities and would be visiting agricultural and industrial sites and projects. They will be making calls on Ministers. The Delegation is scheduled to leave Guyana on Monday, 5th July, 1993.

The Speaker informed Members that the Delegation called on him yesterday and made a presentation of a mini bus to the Parliament Office and that the bus was in the front driveway of the Public Buildings Compound. It is a new beige fifteen seater Toyota Hiace.

The Speaker stated that this was the first vehicle that the Parliament Office had obtained. The Office took action and had the bus registered on 31st July 1993 as PEF 76, and the Office name was painted thereon.

The Speaker also stated that the Parliament Office will be seeking approval for the inclusion in its establishment of a new position of Driver and of the necessary financial provision required and will thereafter appoint the Driver.

The Speaker, on behalf of the National Assembly, expressed sincere thanks to Madame Chen and, through her, to the National People's Congress of the People's Republic of China for the very generous gift to the Parliament Office of a mini bus.

The Speaker further stated that with the need for transportation, the bus was most welcome and will be of great use to the Office. He invited Madame Chen and her Delegation to remain for the proceedings at the sitting of the National Assembly.

The Speaker announced that on the occasion of the 27th Anniversary of the Independence of Guyana, on 26th May, 1993, persons who were honoured with National Awards included present and former Members of Parliament.

Mrs. Janet Jagan, a present Member, was awarded the Order of Excellence (O.E.), for her selfless role, her unflagging commitment and the eminence and distinction achieved by her in the struggle for independence of Guyana and more recently in the restoration of democracy in Guyana.

Mr. Roysie Ramkarran, a former Member, was awarded the Order of Excellence (O.E.), for his outstanding and exemplary political service in the pre and post independence periods in Guyana.

Mr. Earl Maxwell Gladstone Wilson, a former Member, was awarded the Order of Roraima (O.R.), for his outstanding service in the field of education and in the struggle for the independence of Guyana.

Mr. Brindley Horatio Benn, a present Member, was awarded the Cacique's Crown of Honour (C.C.H.), for his outstanding service in the field of politics, especially in the struggle for the independence of Guyana and the restoration of democracy in Guyana.

Mr. Cedric Vernon Hunes, a former Member, was awarded the Cacique's Crown of Honour (C.C.H.), for his outstanding service in the field of education and the struggle for the independence of Guyana.

Mrs. Regina Philomena Sahoye-Shury, a former Member, was awarded the Cacique's Crown of Honour (C.C.H.), for her sustained and outstanding role in the struggle for the independence of Guyana.

Mrs. Christina Ramjattan, a former Member, was awarded the Medal of Service (M.S.), for long and dedicated service in the field of politics.

Also honoured on the occasion was one who had been associated for years with the work of Parliament in the production of Hansard.

Miss Eilren Rosaline Cox, received the Golden Arrow of Achievement (A.A.), for her dedicated and outstanding service as an advocate of consumer protection and as a social worker.

The Speaker extended congratulations.

(iv) Fortieth Anniversary of Ministerial System

The Speaker also informed Members that the 18th of May, 1993, marked the 40th Anniversary of the first sitting of the Legislature of this country under a new Constitution which provided, for the first time for inter alia, a Ministerial system of Government and the Office of Speaker.

Of the persons who were legislators on that occasion, forty years ago, only one is a Member of the present Parliament, and that person is Mrs. Janet Jagan. In that Legislative body, Mrs Jagan was the Deputy Speaker. She was therefore the first Deputy Speaker of Guyana and the only woman so far to hold that Office.

He extended congratulations and best wishes to Mrs. Jagan.
