**(ii) Resignation of Dr. Faith Harding**

The Speaker announced that he had received a letter from Dr. Faith Harding resigning her seat in the National Assembly, with effect from 11th July, 1994.

The Speaker stated that, in accordance with section 99A of the Representation of the People Act, Chapter 1:03, he had called upon the representative of the list of candidates in which Dr. Harding's name was included, to further extract from the said list the name of a person to fill the vacancy in the Assembly.

Dr. Harding had served as a Member of the National Assembly from 28th December, 1985 to 8th October, 1992, and again from 24th November, 1992 to 10th July, 1994. During the period 28th December, 1985 to 8th October, 1992, she was a Minister of the Government.

The Speaker, on behalf of Members of the National Assembly and himself extended best wishes to Dr. Harding.

ITEMS 2 and 3 PUBLIC UTILITIES COMMISSION (AMENDMENT) BILL 1994 -  
Bill No. 3/1994 published 5.2.94

The Senior Minister of Trade, Tourism and Industry moved the following motion:

BE IT RESOLVED:

That the Report of the Select Committee on the Public Utilities Commission (Amendment) Bill 1994, be adopted.

The proposals in the Report which were made by the Select Committee, on the Clauses of the Bill, were as follows:-

Clause 1 was agreed to as printed.

Clause 2 was amended and agreed to as follows:-

Substitution of the words ",enforcement and the other" for the words "and enforcement" in the third line of paragraph (a).

Substitution of the words "In regard to matters provided in sections 26(2), 29 and 33 and the proviso to section 65(1)" for the words "As further provided in sections 26(2), 29, 33 and 65(1)" in the first and second lines of the new subsection (2A) being inserted by paragraph (b).

Deletion of the words ",that has been entered into prior to the date on which this Act came into operation" in the fifth, sixth and seventh lines of the new subsection (2A) being inserted by paragraph (b).

Substitution of the words "laws in operation in Guyana" for the words "written laws" in the third line of the new subsection (2B) being inserted by paragraph (b).

Deletion of the words "by any complainant, public utility and consumers" in the sixth and seventh lines of the new subsection (2B) being inserted by paragraph (b).



Clause 3 was agreed to as printed.

Clause 4 was amended and agreed to as follows:-

Substitution of the word "manner" for "mannel" in the second line of paragraph (a).

Substitution of the words "in any material respect, without" for the word "without" in the second and third lines of paragraph (a).

Deletion of the words "in paragraph (a)," in the first line of paragraph (b) (i).

Clause 5 was amended and agreed to as follows:-

Substitution of the words "provision of safe and adequate service at reasonable costs, and to assuring the financial integrity of the enterprise" for the words "and to assuring confidence in the financial integrity of the enterprise, so as to maintain its credit and to attract capital" in the third and fourth lines.

Clause 6 was amended and agreed to as follows:-

Deletion of the word "telecommunications" in the third line.

Clause 7 was agreed to as printed.

Clause 8 was amended and agreed to as follows:-

Insertion of the following after paragraph (a):-

"(b) in subsection (2) -

(i) by the substitution, for paragraph (a), of the following -

"(i) where it relates to changing any rate or rates -

(a) the existing and duly established rate or rates;"

(ii) in paragraph (e), by the substitution, for the full stop at the end, of a semi-colon;

(iii) by the insertion, after paragraph (e), of the following -

"(ii) where it relates to the rate for any new service -

(a) the date from which the rate for the new service is to take effect; and

(b) any other particulars specified by the Commission." "

Re-lettering of the existing paragraph (b) as paragraph (

Clause 9 was agreed to as printed.

Clause 10 was agreed to with the correction of the following typographical error:

Substitution of the word "notion" for the word "notice" in the second line of paragraph (a) (ii).

Clause 11 was amended and agreed to as follows:-

Insertion of the word "initially" between the words "shall" and "be" in the seventh line of the new subsection (2) being inserted by paragraph (b).

Clause 12 was amended and agreed to as follows:-

Substitution of the words "subsections as subsections (2) and (3)" for the words "subsection as subsection (2)" in the second and third lines of paragraph (b).

Insertion of the words "lawfully being" between the words "rate" and "charged" in the first line of the new subsection (2) being inserted by paragraph (b).

Insertion of the following as subsection (3):-

"(3) Hearings entered upon by the Commission under this section shall be promptly commenced, scheduled and held."

Clause 13 was agreed to as printed.

Clause 14 was agreed to as printed.

Clause 15 was agreed to as printed.

Clause 16 was agreed to as printed.

Clause 17 was agreed to as printed.

Clause 18 was agreed to as printed.

Clause 19 was agreed to as printed.

Clause 20 was agreed to as printed.

Clause 21 was agreed to as printed.


