# ITEM 1 - FINANCIAL INSTITUTIONS BILL 1993 - Bill No. 28/1993 published 12.11.94

"(b) to any person which is affiliated with the officer or director, in which the officer or director owns equity capital or otherwise has a beneficial interest of ten percent or more, or of which the officer or director is a guarantor;"

Clause 14 was then passed as amended.

Clauses 15 to 65 were passed as printed.

#### ITEM 3 - ESTABLISHMENT OF THE ASSOCIATION OF CARIBBEAN STATES

The Senior Minister of Foreign Affairs moved the following motion:

WHEREAS the Conference of Heads of Government of the Caribbean Community, at a Special Meeting in October 1992, considered the recommendations of the West Indian Commission on the Establishment of an Association of Caribbean States;

AND WHEREAS the Conference agreed that the Caribbean Community initiate proposals for the establishment of the Association directed to advancing both economic integration and functional co-operation with the other island states of the Caribbean, Suriname, the states of Central America and the other Latin American countries of the Caribbean littoral;

AND WHEREAS a Preparatory Meeting at Ministerial level, held in June 1994 in Caracas, Venezuela, approved the Final Act of the Convention Establishing the Association of Caribbean States;

AND WHEREAS the Government of Guyana, on July 24, 1994, signed the Convention Establishing the Association of Caribbean States, in Cartagena de Indias, Colombia;
