# Second Statement By The Speaker Concerning A Remark Made By Mr. Idris Deen About The General Secretary Of The Trades Union Congress

The Speaker made the following statement:

'Hon. Members, as you are aware, on Thursday, January 30, 1997, I made a statement in the National Assembly as a result of a Press Release, which was issued by the People's National Congress (PNC) Secretariat. In the Release I was falsely accused of refusing a request by the PNC to address the issue involving the Hon. Member Mr. Idris Deen, who, even the PNC did not attempt to deny, referred to Mr. Joseph Pollydore, General Secretary of the Trades Union Congress, as being senile.

In my said statement to this House, Hon. Members will recall that I mentioned that the Hon. Member Mr. Barrow, in a note, informed me that "Mr. Deen would <u>like to offer an apology</u>, re: Mr. Pollydore's statement" and that I agreed to let Mr. Deen do so at the very first opportunity if it could be done under the Standing Orders, but that Mr. Deen had refused to avail himself of the opportunity to do so.

Hon. Members, one would have thought that the Leadership of the PNC, having seen my statement, would have requested Mr. Deen to apologise as he had informed his Hon. colleague Mr. Barrow or to disassociate itself from Mr. Deen and apologise to Mr. Pollydore or to remain silent and let the matter rest.

Instead, in another Press Release issued on January 30, 1997, the PNC misrepresented the facts in order to malign me.

The said Release further accused me of not understanding my role as Speaker and of being partial in the discharge of my duties.

The said Release does not deny that Mr. Barrow was requested by Mr. Deen to inform me that he, Mr. Deen, wished to apologise for the statement he made about Mr. Pollydore.

The Release also alleged that I did not permit Mr. Deen to provide an explanation: this is untrue.

The PNC Release was that Mr. Deen wanted to make a statement about what he said of Mr. Pollydore whilst Mr. Deen was in his seat and I denied him that opportunity.

I wish to remind Hon. Members, that Mr. Deen was sitting when he used the words "he is senile" and later, whilst standing, Mr. Deen said he did not call anyone's name.

In the Release it is stated "In the first instance the Speaker has been absurd in requesting an apology for a statement allegedly made during the processes of heckling. One had to ask: since when the Speaker takes cognisance of heckling during debate in the National Assembly? That the Speaker has attempted to solicit an apology for an alleged statement which he himself contended was made when the Hon. Member Shree Chan, Minister of Trade, Tourism and Industry, was speaking as opposed to a statement which was formerly made to the National Assembly, supports the view of the PNC's press statement of January 28, 1997, that the intention is to use the incident for nefarious political purposes".

Hon. Members, I never requested an apology nor attempted to solicit an apology from Mr. Deen as alleged in the Release. As to the taking of cognisance of heckling during debate of the National Assembly I have done so on numerous occasions during the Budget Debate last week and on many previous occasions.

What is puzzling to me Hon. Members, is that if I had requested an apology for the statement made during heckling and also of attempting to solicit an apology from Mr. Deen, which I deny: why was Mr. Deen willing to apologise and the PNC is critising me for not permitting him to do so?

The Release implies that the Speaker has no authority to deal with a Member who is sitting and heckling whilst another Member is addressing the House. Such a view in nonsensical and shows a total lack of knowledge of the powers and duties of a Speaker in the conduct of debates and the maintenance of Order in this Honourable House.

A Speaker has very wide powers to prevent disorder over Members in the House whether a Member is addressing the House or not.

The following passages appear in Erskine May. Parliamentary Practice, 21st Edition at page 394; "When any Member... makes any noise or disturbance whilst another Member is speaking, or commits any other breach of order or decorum... it is the duty of the Speaker, if in his judgement the occasion demands it, to interfere and call the Member offending to order". "Where any disorderly or unparliamentary words are used whether by a Member who is addressing the House or a Member who is present during a debate, the Speaker intervenes and calls upon the offending Member to withdraw the words".

I wish to remind Hon. Members that Parliamentary Practice and Procedure will not be found in any written code. The Standing Orders are only part of the rules of procedure. The greater part of Parliament's rules are unwritten. They comprise of practice and conventions to supplement the Standing Orders.

The PNC's Release also states "It is true that the Speaker of the House did not permit Member of Parliament, Mr. Idris Deen to provide an explanation. Rather he demanded that Mr. Deen should meet him in his Chambers. It is clear that he did not want an explanation. What he wanted was time to be able to obtain political mileage for the PPP".

Hon. Members why would I have refused to permit Mr. Deen to provide an explanation if as the Release had earlier stated I had requested and attempted to solicit an apology from Mr. Deen?

In my statement to the House last Thursday I said that I had agreed to permit Mr. Deen to make a statement under the item "Personal Explanations" on the Order Paper and he refused to do so. This is not denied in the PNC Release.

I had requested to see Mr. Deen in my Chambers after the Hon. Mr. Barrow spoke to me. Since I wanted to know what he intended to say.

In the same Edition of Erskine May at page 304, it is stated that "the House will permit a personal statement to be made.... provided that the Speaker has been informed of what the Member proposes to say... Because the practice of the House is not to permit such statements to be subject to intervention or debate, the precice nontents of the proposed statements are submitted in advance to the Speaker to ensure that they are appropriate".

The PNC in its second Release expressed surprise that I did not "comprehend a simple statement" which appeared in their first Release of January 28, 1997 and in which it was stated that Mr. Pollydore was held in high regard by the Leadership and all the Members of the PNC.

Hon. Members, I found it difficult to understand how it can be said that all the Members of the PNC held Mr. Pollydore in high regard when a top PNC "front bench" Parliamentarian said that Mr. Pollydore is senile. It does not matter whether the Member was sitting or standing.

Hon. Members, the discharge of my duties as Speaker was referred to by the Hon. Member Mr. Winston Murray, Chairman of the PNC on December 19, 1995, whilst speaking on behalf of the PNC in the House and extending seasons greetings. He said "We would like, Mr. Speaker, to single you out for special mention. We believe, Sir, that you have maintained the dignity of the Chair and that you have conducted the debates in this Assembly with a great deal of fairness. I would like to congratulate you. I think that augurs well for the future of our Parliament".

Dr. Kenneth King, a former PNC front bencher in his letter of resignation to me dated December 28, 1996, stated "I take this opportunity to thank you for your many kindness to me during my short term in Parliament, and formally to congratulate you on your fairness and objectivity in your exercise of the Office of Speaker".'
