Clause 7 was passed as printed.

Assembly resumed.

" poor law commissioners or a district commissioner " of the words "the commissioners or the Deputy Chief Executive Officer of the Regional Democratic Council". (ii) by the substitution for the words
"not exceeding the sum of two hundred and fifty dollars a week, and any further sum, not exceeding the sum of two hundred dollars a week" of the words "such sum being within the limits prescribed by section 6".

Clause 4 was passed as amended.

<u>Clauses 5 to 30</u> were passed as printed.

Assembly resumed

On a motion by the Minister of Labour, Human Services and Social Security, the Bill was read the third time and <u>passed</u> as <u>amended</u>.

ITEM 5 - MUNICIPAL AND DISTRICT COUNCILS (AMENDMENT) BILL 1997 -Bill No. 25/1997 published 8.8.97

ITEM 6 - CONVENTION AND RECOMMENDATION OF THE INTERNATIONAL LABOUR ORGANISATION

The Minister of Labour, Human Services and Social Security moved the following motion which was <u>put</u> and <u>carried</u>:

WHEREAS as a member state of the International Labour Organisation, Guyana is obligated to examine Conventions and Recommendations adopted by the International Labour Conference in accordance with Article 19 of the Constitution of the International Labour Organisation;

AND WHEREAS Article 19 states that all Conventions and Recommendations adopted by the International Labour Conference must be submitted to the Competent Authority of member states whether ratification of such Conventions is contemplated or not;

AND WHEREAS the submission of Conventions and Recommendations adopted at sessions of that Conference should always be accompanied or followed by a statement or proposal setting out the Government's view as to the action to be taken on the instruments;

AND WHEREAS Guyana adheres to the Constitution of the International Labour Organisation of which it is a member since 1966;

AND WHEREAS the Government of Guyana proposes to use the provisions of the Conventions and Recommendations adopted from time to time by the International Labour Conference as aims of policy and to ratify those Conventions which are in keeping with the social philosophy of the Guyanese society:

BE IT RESOLVED:

Conclusion set out in the State Paper on the undermentioned Convention and Recommendation adopted at the 83rd Session of the International Labour Conference held in June, 1996:-

- (a) Home Work Convention, 1996, No. 177
- (b) Home Work Recommendation, 1996, No. 184;

AND BE IT FURTHER RESOLVED:

That the decision of the National Assembly be conveyed to the Director General of the International Labour Organisation.
