At 6.30 p.m., on a motion by the Minister of Agriculture and Parliamentary Affairs, the Assembly agreed to continue sitting beyond 6.30 p.m., uninterrupted.

## <u>Clause 12</u>

Mr. Lance Carberry, on behalf of and as authorised by, Mr. Raphael Trotman moved the following amendment to the proposed section 11A being inserted in the Representation of the People Act, Chapter 1:03:

Substitution of the following for subsection (4) and for the Table below that subsection:

"(4) The ten geographical constituencies shall elect twenty-five of the members of the National Assembly. The number of members to be elected from each geographical constituency mentioned in the first column of the Table below shall be as shown in the second column of the Table.

Thereafter, the Members of the People's National Congress withdrew from the Chamber.

Dr. Rupert Roopnaraine moved the following amendment to the proposed section 11B being inserted in the Representation of the People Act, Chapter 1:03:

Substitution of the following for subsection (8):

"(8) The order in which the names of candidates appear on a List shall be the order in which the Representative of that List shall appoint members as elected to the National Assembly and the Clerk shall ascertain that members of each list have been named in that order."

The amendment was put and negatived.

The Minister of Agriculture and Parliamentary Affairs moved the following amendments to the proposed section 11B being inserted in the Representation of the People Act, Chapter 1:03:

Renumbering of subsection (8) as subsection (9).

Insertion of the following as subsection (8):

- "(8) In the extraction from the lists and declaration of names of the candidates who have been elected account shall be taken -
  - (i) of the total number of females on each party's national top-up lists and the lists for geographical constituencies, taken together, being at least one-third of the number of persons on those lists as mentioned in paragraphs (5), (6) and (7); and
  - (ii) of the proportion that women form of the electorate."

The amendments were put and carried.

The Minister of Agriculture and Parliamentary Affairs moved the following amendment to section 39A (1) (a), being inserted in the Representation of the People Act, Chapter 1:03:

Insertion of the following after the word "party:" at the end of paragraph (a):

"but the serial numbering on the ballot paper under paragraph (a) and the serial numbering on the counterfoil, under paragraph (c), shall be done in such a manner as to ensure that the two sets of serial numbers cannot be correlated:"

The amendment was put and carried.

Clause 12 was passed as amended.

#### Clause 13

The Minister of Agriculture and Parliamentary Affairs moved the following amendment to subsection (2):

Substitution of "99 to 101 (inclusive)" for "99, 100, 101"

The amendment was put and carried.

Clause 13 was passed as amended.

Clauses 15 to 24 were passed as printed.

### Assembly resumed.

On a motion by the Minister of Agriculture and Parliamentary Affairs, the Election Laws (Amendment) Bill 2000 was read the third time and <u>passed</u> as <u>amended</u> on the following division:
