#### (i) Changes in the National Assembly

The Speaker made the following announcements with respect to changes in the National Assembly:-

#### (a) Cde. H.D. Hoyte's Assumption of the Office of President

Following the death on 6th August, 1985, of Cde. Linden Forbes Sampson Burnham, O.E., S.C., the Prime Minister, Cde. Hugh Desmond Hoyte, S.C., M.P., had, in accordance with the Constitution, assumed the Office of Fresident, and had ceased to be a Member of the National Assembly.

On behalf of Members and his own, the Speaker extended congratulations and best wishes to Cde. Hoyte in his new and in the highest office.

#### (b) Appointment of Cde. Hamilton Green as Prime Minister

With effect from 6th August, 1985, the new President had appointed Cde. Hamilton Green, who had been Vice-President, Social Infrastructure and First Deputy Prime Minister, to be Prime Minister.

On behalf of the Members and his own, the Speaker congratulated Cde. Green on his appointment as Prime Minister and extended best wishes to him.

### (c) Appointment of Cde, Dr. Mohamed Shahabuddeen, O.R., S.C., as First Deputy Prime Minister

Cde. Dr. Mohamed Shahabuddeen, O.R., S.C., who had been Vice-President, Leputy Prime Minister and Attorney General, had been appointed First Deputy Prime Minister, his new designation being Vice-President, First Deputy Prime Minister and Attorney General.

### (d) Appointment of Cde. Viola V. Burnham, O.R., as Vice President

Cde. Viola Victorine Burnham, O.R., had been appointed a Vice-President and designated Vice-President, Social Development and Deputy Prime Minister, with effect from 15th August, 1985. Cde. Burnham who was not an elected Member of the National Assembly became, by virtue of holding the office of Vice-President, a Member of the National Assembly.

On behalf of the Members and his own, the Speaker congratulated Cde. Burnham on her appointment, welcomed her to the Assembly and extended best wishes to her for success in her responsibilities.

#### (e) Election of Cde. Jeffrey R. Thomas to fill Vacancy

The vacancy in the Assembly which had been created sometime ago by the resignation of Cde. Huldah Walcott-Nascimento had been filled by Cde. Jeffrey Ronald Thomas who had been a non-elected Minister, designated Minister of Home Affairs. Cde. Thomas had been declared to be an elected Member of the Assembly with effect from 10th September, 1985.

#### (f) Election of Cde. Kenneth W.E. Denny to fill Vacancy

With Cde. Hoyte's assumption of the Office of President a vacancy had been created in the Assembly and, in accordance with section 99A of the Representation of the People Act, Chapter 1:03, the Speaker had called upon the Deputy Representative, in the absence of the Representative, of the list of candidates from which Cde. Hoyte's name had been extracted, following the last general elections, to further extract from the said list, the name of a person to fill the vacancy.

He had been informed that the name of Cde. Kenneth Wesley Edward Denny had been extracted from the list and that Cde. Denny had been on 10th September, 1985, declared to be an elected Member of the National Assembly to fill the vacancy. Cde. Denny had been a non-elected Member of the Assembly, designated Minister of Manpower and Co-operatives.

On behalf of Members and his own, the Speaker extended congratulations to Cde. Thomas and to Cde. Denny on their becoming elected Members of the Assembly and he also extended best wishes to them.

### (g) Appointment of Cde. Yvonne V. Harewood-Benn as a Senior Minister

On 15th August, 1985, Cde. Yvonne Veronica Harewood-Benn, who had a Minister within the Ministry of Education, had been appointed a Senior Minister and had been designated Minister of Information and the Public Service.
