QUESTIONS TO MINISTERS

No. 29 - REAGENTS AT LABORATORIES

Cde. Janet Jagan asked the Prime Minister the following questions:

- <u>QUESTION:</u> (i) Can the Prime Minister say if there are sufficient reagents to supply all laboratories, including the blood transfusion centre?
 - (ii) Is it true that a shortage of reagents curtailed laboratory investigations into AIDS (HIV), typhoid, hepatitis and diabetes sometime this year?
 - (iii) Can the Prime Minister give an assurance that there will be no more shortage of reagents?

No. 34 - EFFECTS OF THE SWEETENER INDUSTRY ON THE MARKETING OF CANE SUGAR

<u>QUESTION:</u> How will the involvement of Tate & Lyle in the sweatner industry, and its plan to build a polydextrose plant on the site of a sugar refinery in Canada affect the marketing of cane sugar as convevied by **Booker/Tate?**

PUBLIC BUSINESS

MOTIONS

ITEM 1. EXAMINATION OF ENTITIES TO BE DIVESTED

Cde. Reepu Daman Persaud moved the following motion:

BE IT RESOLVED:

That the process of divestment be suspended and each entity proposed for divestment be subjected to a thorough examination by a special Parliamentary Committee to be constituted by all Parties represented in the National Assembly and that the said Committee be given the authority to consult and involve other political and socio-economic organisations and individuals in its work;

AND BE IT FURTHER RESOLVED:

That the said Committee report its findings and/or recommendations to the Assembly within the shortest possible time and well in advance of the General Elections. Mr. Kwayana second and spoke to the motion.

The Deputy Prime Minister, Planning and Development spoke to the motion.

The Deputy Speaker replied. The motion was put and negatived.

ITEM 2. INCREASE IN PERSONAL INCOME TAX ALLOWANCES

Cde. Reepu Daman Persaud moved the following motion:

BE IT RESOLVED;

That this National Assembly calls upon the Government to increase Personal Income Tax Allowances in all categories commensurate with the drastic increase in the cost of living.

Cde. Belgrave seconded the motion.

The Minister of Finance was speaking when the time for the suspension of sitting was reached.

SUSPENSION

At 4:00 p.m. the Assembly was suspended for refreshment.

RESUMPTION

At 4:30 p.m. the sitting was resumed.

The Minister of Finance continued and concluded has speech. Cde. Belgrave and Mr. Kwayana spoke to the Motion.

The following amendment which was moved by the Minister of Finance was put and carried.

Deletion of the words that follow 'to' in the second line and substitution of the following "C

"Continue to keep under active review personal income tax allowances with a view to their periodic adjustment".

ITEM 3 - ASSIGNMENT OF WOMEN JUDGES TO RAPE CASES

Cde. Reepu Daman Persaud moved the following motion:

BE IT RESOLVED:

That women Judges be assigned to preside at the hearing of rape cases as far as is practicable.

Cde. Janet Jagan seconded and spoke to the motion.

Mrc Kwayana and the Attorney General and the Minister of Legal Affairs spoke to the motion.

The motion was put and negatived.

ITEM 4 - EVIDENCE AND PROCEDURE IN RAPE CASES

Cde. Reepu Daman Persaud moved the following motion:

BE IT RESOLVED:

That this National Assembly ggrees that the laws of evidence and procedure be reviewed by the Attorney General to provide in cases of rape for the following:-

- (i) the victim's name be withheld from publication
- (ii) the preliminary hearing and trial of persons charged with rape be held in **Genera**
- (iii) the cross-examination of the complainant as regards previous sexual relations be limited to her sexual relations with the accused and not generally
- (iv) the panel of jury to be comprised of six men and six women;

AND BE IT FURTHER RESOLVED:

That the relevant amendments to the laws be introduced for approval of the National Assembly without delay.

Cde. Janet Jagar seconded and spoke to the motion.

ADJOURNMENT

At 6:27 p.m. on a motion by the Minister of Regional Development the Assembly was adjourned to 2:00 p.m. on Thursday, 19th July, 1990.
