<u>In Committee</u>

Clause 4 The Deputy Speaker moved the following amendments:-

- (i) Amendment to the proposed new Section 3R(1)

 Insertion of the words "and shall have transmitted to each political party contesting the elections not less than five certified copies of such list" after the words "section 3A".
- (ii) Amendments to the proposed new Section 3£ =
 - (a) renumbering of subsections (5), (6), (7), (8),
 and (9) as subsections (6), (7), (8), (9) and
 (10)respectively;
 - (b) <u>insertion</u> of the following as subsection (5) "(5) Any vacancy created pursuant to subsections (3) and/or (4) shall be filled in like manner by which the original appointment was made.";
 - (c) <u>insertion</u> of the following as subparagraph (iii) of the renumbered subsection (6)(a) \leftarrow
 - "(iii) birth certificate, passport or any other document substantiating the age and/or identification of the applicant.";
 - (d) <u>Insertion</u> of the following immediately after subsection (1) -
 - "(1)(a) Every scrutineer appointed in accordance with this section shall be paid from funds provided by Parliament such remuneration as may be determined by the Elections Commission."
 - (c) <u>substitution</u> of the following for the renumbered subsection (6)(b) -
 - "(b) shall, by virtue of his appointment as a scrutineer, be entitled as of right to visit any house or the premises thereof in company with an enumerator, while the enumerator is performing

his duties under this Act, in the registration division for which the scrutineer is appointed and shall be entitled to receive from the enumerator all particulars given by the elector upon application for registration.";

(f) substitution of the following for subsection (2) -

"(2) The Commissioner or Divisional Registrar shall be given notice in writing of the appointment of a person as scrutineer, by the authorised person, Chief Scrutineer or Assistant Chief Scrutineer appointing him, and the Commissioner or Divisional Registrar shall issue to him an identification card which should be surrendered promptly by the scrutineer to the Commissioner on the termination of his appointment and references in the following sub-sections to a scrutineer shall, unless the context otherwise requires, be deemed to be references to a person appointed as a scrutineer under sub-section (1) and to whom an identification card has been issued by the Commissioner.".

On a motion by Mr. Kwayans the following words "with the consent of the householder" were substituted for the words "as of night" in the amendment to the renumbered subsection 6(b).

The amendments were put and negatived.

The following amendment by the Attorney General and Minister of Legal Affairs was put and <u>carried</u>:

In the proposed new section 3F for the words "Section 12 of that Act" <u>substitution</u> of the words "section 12 of the National Registration Act" and <u>insertion</u> of "Cap. 19:08" in the margin.

Clause 4 was then passed as amended.

Assembly resumed

On a motion by the Attorney General and Minister of Legal Affairs, the Bill was read the third time and <u>passed</u> as <u>amended</u>.

ITEM 4 - REPRESENTATION OF THE PEOPLE (AMENDMENT) BILL 1990 - Bill No. 35/1990 published 1990-12-17

The Attorney General and Minister of Legal Affairs moved the second reading of the following Bill:

A Bill intituled An Act to amend the Representation of the People Act.

The Deputy Speaker, Mr. Abraham and Mr. Kwayana spoke to the motion.

Thereafter the Attorney General and Minister of Legal Affairs replied.

The motion was put and carried.

The Bill was road a second time.

SUSPENSION OF STANDING ORDER NO. 9(1)

At 9.55 p.m., on a motion by the Minister of Regional Development, Standing Order No. 9(1) was suspended to enable the Assembly to sit beyond 10.00 p.m. to complete the business on the Order Paper.

Clause 4 The following amendment by the Attorney General and Minister of Legal Affairs was put and carried:

Substitution of the following for the proviso in subsection (4) inserted in section 65L of the Principal Act -

"Provided that in their application by virtue of this subsection, sections 87, 88 and 90 shall have effect as if for the reforence in those sections to a counting agent there had been substituted reference to an election agent.".

Clause 4 was then passed as amended.

Clause 5 The following amendments by [:r. Abraham were withdrawn:

(1)-substitution of the following for the proposed new section 83A(1) -

"At least two polling agents or duly appointed candidates to be determined by the majority of the opposition polling agents at a polling place shall accompany the ballot boxes in the same conveyance carrying ballot boxes from that polling place to a returning officer." and

- (ii) <u>Insertion</u> of the following as subsection (3) in the proposed new section 83A -
 - "(3) upon delivery of a ballot box to a returning officer, the presiding officer in the presence of contesting political parties shall publicly declare the results of the preliminary count".

The Deputy Speaker moved the following amendment:

Insertion in the proposed new section 83A(2) the words

"and to remain with the said ballot boxes upon same being delivered to the returning officer until the final count is declared" after the words "a returning officer".

The amendment was put and negatived,

Clauses 6 to 13 were passed as printed.

Assembly, resumed

In a motion by the Attorney General and Minister of Legal Affairs, the Bill was read the third time and passed as amended.
