ANNOUNCEMENTS BY THE SPEAKER,

(i) <u>New Year Greetings</u>

Since it was the first sitting for the New Year, the Speaker took the opportunity of welcomizing and extending best wishes to the Members of the Assembly.

(ii) <u>Ministerial Changes</u>

The Speaker informed Members that on 30th December, 1986, all the Ministers and Parliamentary Secretaries resigned from their respective offices. ITEM 1 - OLD AGE PENSIONS

Cde. Janet Jagan moved the following motion, and requested that "\$67.00" be substituted for "\$50.00" therein:

WHEREAS sections 4 and 5 of the Old Age Pensions Act, Chapter 36:03, provide for certain statutory conditions to be fulfilled by every person (Claimant) before he can receive pension and that in the calculation of the means of any person for the purposes of the Act, account must be taken of the income of that person from specified sources;

AND WHEREAS the person must also satisfy the appropriate authorities (the Poor Law Commissioners) that the monthly income as calculated under the Act does not exceed such amount as the Minister, by Order, may prescribe; AND WHEREAS the sum of \$50.00 so prescribed at present is so low as to depress and keep depressed below that figure any moneys the person may be entitled otherwise to receive, in short, he cannot have an income of \$50.00 or more and receive as well Old Age Pension of \$50.00 a month;

AND WHEREAS, further, the Act provides for claims to be heard by appropriate authority "without delay" but many claimants for Old Age Pension are known to suffer unconscionable delays in receiving pensions or in having their appeals heard and often do not know and are not notified, as provided with the reasons if the applications are rejected;

AND WHEREAS, also section 6 empowers the Poor Law Commissioners to take into account all information concerning the means of any person, and shall thereupon decide whether or not the person shall be paid: and this proviso is to worded as to appear to be accountable in some degree for the many accusations of discrimination that have been made from time to time;

BE IT RESOLVED:

That this National Assembly calls upon the Government -

- (i) to remove the "Means Test" and raise without delay the present figure of \$50.00 a month to a sum more in keep-ing with the present cost of living, in order to give some relief to the desperate condition of so many elderly people; and
- (ii) to have the out-dated Old Age Pensions Act amended to reflect the current needs of pensioners.

Cde. Nokta seconded the motion.

The Speaker proposed the motion and Mr_{\bullet} E. Kwayana and the the Minister of Labour and Ede. Belgrave spoke to the motion

Thereafter, the motion was put and negatived.

ITEM 3 - TRADE WITH SOUTH AFRICA

Mr. Kwayana moved the following motion:

BE IT RESOLVED:

That Trade Order No. 51 of 1964 prohibiting trade in goods with the Union of South Africa to be amended to include invisible trade;

BE IT FURTHER RESOLVED:

That the public sector should cease and the Government should prohibit business relations with firms which participate in the apartheid economy in South Africa and Namibia;

BE IT FURTHER RESOLVED:

That no such business or commercial relations be entered into unless the Government satisfies this Assembly beforehand that an exception ought to be made in the particular case;

AND BE IT FURTHER RESOLVED:

That this Government support these positions at Commonwealth conferences.

Cde. H. Nokta seconded the motion.

The Minister of Trade and Tourism, the Minority Leader spoke to the motion.

The Minister of Foreign Affairs moved the following amendments:

Insertion of the words "the regine established by the" after the first word of the first Clause and also insertion of the words "strenghtened by appropriate legislation" after the word "be" in the very clause.

Deletion of the words "Should cease" after the word "sector" in the second clause.

Substitution of the words "continue to ensure that" for the "prohibit" in the second clause.

Insertion of the words "are prohibited" after the last word of the second clause.

Deletion of the third Clause.

<u>Insertion</u> of the words "continues to" after the word "Government" in the fourth clause.

Insertion of the words "and all other international" after the words "Commonwealth" in the fourth clause.

These amendments by the Minister of Foreign Affairs were put and carried.

The motion as amended was then put and carried.
