QUESTIONS TO MINISTERS -

No. 13 - Cattle Rustling in the Rupununi

Mr. Kwavana asked the Minister of State in the Ministry of Home Affairs the following question:

- QUESTION: (i) Is it true that in or about the month of March 1986 a special police detachment was dispatched to the Rupunumi to investigate the rustling of cattle?
 - (ii) Is it true that as a result of their visit a number of Rupununi residents were arrested and charged?
 - (iii) What is the number of residents charged with offences connected with cattle rustling or arising out of the visit of the special police detachment?

- (iv) Is it true that, following reports of police brutality during the investigation mentioned in question (i), the Government dispatched a mission to the Rupununi to investigate?
- (v) If a mission was dispatched will the Minister of State say who comprised it and what were its findings?
- (vi) Can the Minister of State say whether the residents charged are represented by counsel?

The Minister of State in the Ministry of Home Affairs gave the following reply:-

ANSWER: (i), (ii) and (iii) - The Commissioner of Police did receive a letter alleging police brutality in general terms. Complaints were investigated by the Officer-in-Charge of the Division (Rupununi). The Commissioner of Police having had the complaints investigated was fatisfied that the report on police brutality was not so.

(iv), (v) and (vi) - The Government did not dispatch a mission to the Rupununi.

No. 14 Assets of the Late President of Guyana

Mr. Kwayana asked the Minister of Finance the following question:

QUESTION: Will the Minister, in view of the fact that he was not a private citizen and stood as Head of the Guyana Government from December 14, 1964 to August 6, 1965, investigate the assets wherever held of the late President of Guyana, Mr. Linden Forbes Sampson Burnham, and make a report on their nature and their gross and net value, with the necessary information to the Guyanese people, taking into account widespread public interest in the matter?

The Deputy Prime Minister, Planning and Development, gave the following reply:

ANSWER: Standing Order 17 (1) (f) provides that a 'question shall not contain arguments, inferences, opinions, imputations, epithets, ironical expressions or hypothetical cases'. The cryptic subtlety with which the question before the House has been crafted only serves to throw into higher relief the depravity and maliciousness of the wholly unprovem imputations which it seeks to convey. In my respectful view, the question falls totally outside of the pale of decency so anxiously delimited by the Standing Order.

However, even if the question is technically admissible, it fails altogether to present the slightest substratum of factual material to justify the entries of any powers of investigation which the Minister of Finance may have, or indeed which any public agency may have.

As I understand it, the request for an investigation is based on two grounds, viz.

- (i) the fact that the late President 'was not a private citizen and stood as Head of the Guyana Government from December 14, 1964, to August 6, 1985'; and
- (ii) alleged 'widespread public interest in the matter'.

The first ground is not acceptable because it would require us to automatically delve into the private affairs of other Heads of State on their death simply because they are not private citizens. The preposterous nature of such a proposition is its own refutatiom.

As regards the second ground, the 'alleged widespread public interest' is a figment of the imagination of Mr. Eusi Kwayana. No material whatsoever has been presented to substantiate the existence of the alleged public interest or to exhibit its precise basis. This question represents an attempt to imbue his own droll curiosity with a degree of respectability by wrapping it up in allegations of national interest.

Perhaps I should end by pointing out that under the law the Commissioner of Inland Revenue is the responsible officer for investigating the assets of a deceased person with a view to ascertaining 'their nature and their gross and net value' as referred to in the question. For this purpose he is clothed by law with adequate power to call for all necessary information and to carry out all necessary enquiries.

I feel certain that the Commissioner is fully aware of the nature and extent of his authority and does not need to be reminded of them by the wholly distasteful and reprehensible question with which it has been sought to sully a great name and disfigure the records of this Honourable House.

Kwayana asked a supplementary question.

No. 27 - Cost of Construction - Square of the Revolution

<u>Cde.</u> Reepu <u>Daman Persaud</u>, on behalf of the Minority Leader asked the Minister of Communications and Works the following question:

- QUESTION: (i) Is it true that the cost of construction for the bitumen pave and stands at the "Square of the Revolution" was \$4.3 million?
 - (ii) If not, what was the actual cost?
 (Notice Paper No. 68 published 1986-06-05)

The Minister of Communications and Works gave the following reply:

ANSWER: (i) The answer to (i) is No.

(ii) The actual cost was \$2,588.904.

No. 28 - Ceasing of Nuclear Testing

<u>Cde. Reepu Daman Persaud</u>, on behalf of the Minority Leader asked the Minister of Foreign Affairs the following question:

QUESTION: Will the Minister say whether Guyana will support the call made by the six non-aligned nations in a letter sent to President Reagan and Mr. Gorbachyov, urging the two leaders to stop nuclear testing, and to prevent the militarisation of outer space?

The Minister of Regional Development, on behalf of the Minister of Foreign Affairs, gave the following reply:

ANSWER:

Not all the nations which are involved in the initiative taken with the USA and the USSR on the question of nuclear disarmament are non-aligned. Guyana has supported all calls for an end to nuclear testing and the prohibition of the introduction of new weapons systems into outer space. At the Eight Summit Conference of Heads of State of Government of Non Aligned Countries, held in Harare in September 1986, a call was made on "all states, in particular those with major space capabilities to refrain from taking any measures aimed at developing, testing or deploying weapons and weapon systems in outer space."

At that Summit, His Excellency President Hugh Desmond Hoyte proposed that a message be sent to the leaders of the two major nuclear powers "calling on them to institute a moratorium immediately on nuclear tests...." The proposal was accepted by the Conference and embodied in the Harare Appeal on Disarmament.

No. 29 - Quantity. Price and Disposal of Gold

<u>Cde. Reepu Daman Persaud.on</u> behalf of The Minority Leader, asked the Minister of Finance the following question:

QUESTION: Will the Minister say -

- (i) how much gold was bought by the Guyana Gold Board during 1985;
- (ii) at what price; and
- (iii) where and how is the gold sold or otherwise disposed of?

The Deputy Prime Minister, Planning and Development, on behalf of the Minister of Finance, gave ... following reply:-

ANSWER: (i) During 1985 the Gold Board bought 10,329 Oz. of gold.

- (ii) At an average price of G\$1919. 43/oz.
- (iii) The gold is sold to brokers in London, UK, Washington and U.S.A.

No. 37 - Maintenance of Sea Defences, East Bank Essequibo

<u>Cde. Nokta</u> asked the Senior Minister in the Ministry of Agriculture the following question:

- QUESTION: (i) Is the Minister aware that the poor maintenance of Sea Defences on the East Bank Essequibo has resulted in serious flooding, loss of livestock and damage to crops in the east half of Bush Lot and Reliance area?
 - (ii) If so, will he say what efforts are being made to prevent a recurrence?
 - (iii) Will the Minister also say whether consideration is being given to the payment of compensation to those residents who have suffered losses?

The Senior Minister in the Ministry of Agriculture gave the following reply:

ANSWER:

I am not aware of flooding in places referred to in the question but it is presumed that the questions was referring to Bush Lot and Reliance on the West Coast of Essequibo. The Government is aware that during the period 24th to 30th March, 1986 there was over-topping because of tides above the normal high tides. About nine to twelve inches of water was lodged on the eastern side of the Public Road between Bush Lot and Reliance, a distance of about half a mile and involving about 45 houses. There was no reported loss of livestock, no reported damage to crops or other losses. There have been no claims, consequently the question of compensation does not arise. However, since the occurrence the drains have been de-silted and the height of the dam has been increased by three feet with an additional two feet of bloder protection,

Living next to the Atlantic Ocean is a legacy which we inherited and while the Government continues to spend at the rate of \$5,000 per foot to protect its citizens from the ravages of the Ocean by the very nature of sea defences, no Government anywhere in the world can prevent overtopping of the ocean.

No. 39 - Prisoners' Meals and Mails

<u>Cde. Janet Jagan</u> asked the Minister of State in the Ministry of Home Affairs the following question:

- QUESTION: (i) Will the Minister provide a chart of the daily meals for a period of one week at the Mazarunii Prison, having regard to reports that prisoners' meals are nutritionally inadequate?
 - (ii) Will the Minister say why permission for prisoners to send or receive mail has been restricted to once monthly instead of weekly or fortnightly?

No. 40 - Information on President's College

<u>Cde. S.F. Mohamed</u> asked the Vice-President, Education and Social Development, and Deputy Prime Minister the following question:

QUESTION: Will the Minister say -

- (i) How many students are presently enrolled and how many teachers are presentlt employed at the President's College?
- (ii) How many security guards are employed at this College?
- (iii) How many persons are employed to work in the farm attached to the President's College?
- (iv) What is the estimated monthly operational costs for the President's College?
- (v) (a) Does ideological education form part of the curriculum of the President's College and are subjects related to socialism presently taught?
 - (b) If there is such a programme could the Minister kindly make same available to members of the National Assembly?

(Notice Paper No. 48 published 1986-06-13)

The Vice-President, Education and Social Development and Deputy Prime Minister gave the following reply:

- ANSWER: (i) The number of students enrolled at President's College is one hundred and twenty-eight (128).

 There are 62 girls and 66 boys. The number of teachers on staff at present is twenty-six (26).
 - (ii) Security by its very nature, would become ineffectual if details about it become public knowledge. Consequently, it would be improper for me to discolose the number of guards employed at the College. Lowever, in view of the fact that the College stands on 400 acres of unfenced lands and there has to be security of person (adults and children), property (including building materials), stock and crops, it is necessary that there should be a number of persons equal to the task of securing persons and premises. I assure this House that the present guard strength is adequate for the time being.

- (iii) I presume that by "Farm attached to President's College" Cde. Mohamed is referring to the Agricultural Sector of the College. The number of persons employed in this Sector is 49. They are engaged in cash-crop cultivation, in dairy farming, pig and sheep rearing, poultry (layers and meat birds) and duck rearing, fish farming in four pends and rice cultivation of an area of 30 acres.
- (iv) The estimated monthly operational costs amout to \$143.000.00
- (v) (a) Ideological education in its broadest sense informs the entire curriculum of the College. Social Studies and National Policy are two of the subject areas which relate to Socialism.
 - (b) There is no specific programme of instruction therefore I cannot respond to Cde. Mohamed's request for such a document.

No. 41 - Inquiry into Death of Ramkissoon Saymar

<u>Cde_Collymore</u> asked the Vice-President, First Deputy Prime Minister and Attorney General the following question:

QUESTION: Will the Attorney General say what has been the outcome of the inquiry into the death of Ramkissoon Saymar while in Police custody in Brickdam Police Station?

The Minister of State in the Ministry of Home Affairs on behalf of the Vice-President, First Deputy Prime Minister and Attorney General gave the following reply:

ANSWER: The inquest found no one criminally responsible.

No. 42 - Sale of Gasolene in Wakenaam

<u>Cde. Nokta</u> asked the Deputy Prime Minister, Planning and Development, the following question:

- OUESTION: (i) Will the Minister say what are the reasons for the closure of the only gasolene station in Wakenaam?
 - (iii) Will the Minister say whether it is intended to re-establish a gasolene station in Wakenaam?
 - (iii) Is the Minister aware that gasolene is at present being sold out of barrels in the vicinity of the Transport and Harbours.

 Department Stelling in Wakenaam in violation of safety regulations, and that this poses a threat to the safety of the public and property?
 - (iv) Will he ensure that the sale of the gasolene complies with the legal requirements for carrying on this type of business?

The Deputy Prime Minister, Planning and Development, gave the following reply:

- ANSWER: (i) Amin's gas station was closed in 1984 as a result of perceived malpractices, including blackmarket sales and treating non-legally with gold-miners.
 - (ii) In the interim, the Regional Administration made arrangements to keep the community supplied. I am not totally familiar with those arrangements but I would not be surprised if there were inelliciencies and other inadequacies of the service.
 - (iii) Amin's gas station was re-opened in August, 1986 with appropriate assurances given by the owner of his intention to puruse due regularity.
 - (iv) Instructions have been issued to ensure the cessation of the interim arrangements.

Cde. No! taasked a supplementary question.
