# ANNOUNCEMENTS BY THE SPEAKER

#### (i) NATIONAL AWARDS

The Speaker announced that on the occasion of the second Anniversary of the Republic, six Parliamentarians had been those granted National Awards:-

- (a) Cde. Seeram Prashad had been granted the Cacique's Crown of Honour for political service;
- (b) Cde. Kenneth Berkely Bancroft had been granted the Golden Arrow of Achievement for long and dedicated service in the fields of mining, social and community work in the hinterland areas and in politics;
- (c) Cde. Malcom Corrica, also known as the Mighty Canary had been granted the Medal of Service for long service with exceptional dedication in the fields of politics and popular music as a composer and entertainer;
- (d) Cde. Harry Doobary also known as Herdo Persaud, had been granted the Medal of Service for long service with exceptional dedication in the fields of politics, and in community and social work;
- (e) Cde. Clarice Agatha Edwards had been granted the Medal of Service for long service of a dedicated nature in the field of religion and as a social and community leader.

# (ii) DEATH OF CDE. FREDERICK RUDOLPH WILLS

The Speaker informed Members of the death of Cde. Frederick Rudolph Wills which had occurred in the U.S.A. Cde. Wills was not an elected Member of the National Assembly but by virtue of his being appointed to the office of Minister of Foreign Affairs and justice from 24th April, 1975 to 12th February, 1978 became a Member of the National Assembly. He said that later the Assembly would consider a motion of sympathy on his death.

#### (iii) DESTRUCTION OF HOME OF DEPUTY CLERK BY FIRE

The Speaker reported that on 5th of this month, the home of our Acting Deputy Clerk was gutted by fire. Cde. Kendall and his family had suffered total loss of all their personal possession and as a matter of fact the only items saved were what they had been wearing at the time of the fire. On behalf of Members and his own, he extended sympathy to Cde. Kendall and his family, and wished that they would overcome their disaster in the near future.

#### RESIGNATION OF MR. EUSI KWAYANA

Cde. Speaker announced that he received a letter from Mr. Eusi Kwayana tendering his resignation as a Member of the National Assembly with effect from 24th January, 1992 and that with his r resignation a vacancy had been created in the National Assembly. In accordance with section 99A of the Representation of the People Act, Chapter 1:03, he had called upon the Representative of the list of Candidates from which Mr. Kwayana's name was extracted, to further extract from the said list the name of a person to fill the vacancy.
