The Speaker informed Members that following the resignations with effect from J6th August, 1984, of Comrades Dr. Ptolemy Alexander Reid, O.E., and Bishwaishwar Ramsaroop, as Members of the National Assembly, and his call upon the representative of the List of ^Candidates from which ^Comrades Reid's and Ramsaroop's names had been extracted, he had been informed that the names of the two persons who had been extracted from the said list to fill the vacancies in the Assembly were :-

and that they had been declared to be elected Members of the National Assembly on 20th August, 1984. Cde. Dr. Van West-Charles who had been a non elected Minister had become an elected Member of the National Assembly and had to make and subscribe the oath again as such. Cde. Yusuf Khan as a new Member of the Assembly was required to make and subscribe the oath.

Thereafter Cdes. Dr. R.A. Van West-Charles and Yusuf Khan who were present made and subscribed the oath.

ANNOUNCEMENTS BY THE SPEAKER

(i) Changes in the assignment of responsibilities to Ministers, etc.

The Speaker informed Members that, following the retirement of Cde. Dr. Ptolemy Alexander Reid as Prime Minister, he had informed that the President had made a number of changes in the assignment of responsibilities to Ministers and in the functions of Parliamentary Secretaries and in designations of styles. For the information of Members of the Assembly, and for inclusion in the records, he announced the following changes, all of which became effective from 16th August, 1934:-

- Cde. Desmond Hoyte, who had been Vice-President, Production, had been appointed Prime Minister.
- Cde. Hamilton Green, who had been Vice-President, Social Infrastructure, had been appointed First Deputy Prime Minister and his new designation was Vice-President, Social Infrastructure, and First Deputy Prime Minister.
- Cde. Dr. Mohamed Shahabuddeen, who had been Vice-President and Attorney General, had been appointed a Deputy Prime Minister and was designated Vice-President, Deputy Prime Minister and Attorney General.
- Cde. Ranji Chandisingh, who had been Minister of Education, Social Development and Culture, had been appointed a Vice-President and a Deputy Prime Minister, and was designated Vice-President, National Development and Deputy Prime Minister.
- Cde. Haslyn Parris, who was not an elected Member of the National Assembly, had been appointed a Deputy Prime Minister, and was designated Deputy Prime Minister, Planning.
- Cde. Jeffrey Thomas, Minister of Home Affairs, had been assigned responsibility also for Parliamentary Affairs.
- Cde. Carl Greenidge, who had been Minister of Finance and Economic Planning, had been re-designated Minister of Finance.
- Cde. Sallahuddin, who had been Minister within the Ministry of Agriculture, had been appointed a Senior Minister and designated Minister of Forestry.
- Cde. Dr. Richard Van West-Charles, Minister of Health and Public Welfare, had been appointed a Senior Minister.

- Cde. Malcolm Parris, who was not an elected Member of the National Assembly, had been appointed a Senior Minister and designated Minister of Education.
- Cde. Urmia Johnson, who had been Minister in the Office of the Prime Minister, was Minister in the Ministry of National Devolopment.
- Cde. Yvonne Harewood-Benn, who had been Minister of Information and Public Service, was Minister within the Ministry of Education.
- Cde. Dr. Simpson DaSilva, who was not an elected Member' of the National Assembly, had been appointed a Minister and designated Minister within the Ministry of Agriculture.
- Cde. Donald Ainsworth, who had been Parliamentary Secretary within the Ministry of Education, Social Development and Culture, was Parliamentary Secretary, Youth.
- Cde. Basdeo Bhaggan, who had been Parliamentary Secretary in in the Office of the Prime Minister, was Parliamentary Secretary, National Development.
