OFF-SHORE BANKING BILL 1986 - Bill No. 4/1986 published 1986-03-15

The Bill was read a second time.

Assembly resolved itself into Committee to consider the Bill clause by clause.

- (i) Insertion of the words " and commencement" after the words "Short title" in the marginal note.
- (ii) Insertion of the words "and shall come into operation on such date as the Minister may appoint by order" after "1986".

Clause 1 was then passed as amended.

Clause 2 The following amendments by the Minister of Finance were put and carried:

- (i) Substitution of "2(1)" for "2."
- (ii) Substitution of the word "Bank" for "Banking" in paragraph (b).
- (iii) Insertion of the following after paragraph (e):-

'(f) "non-resident" means a person who is not "resident in Guyana" within the meaning of the Income Tax Act;'

Cap.81:01

- (iv) Relettering of paragraphs (f), (g) and (h) as paragraphs (g), (h), and (i), respectively.

- (v) Insertion of the following as subsections (2) and (3):-

"(2) The functions conferred by this Act on the Bank shall, during the period beginning from the commencement of this Act and ending on such date as may be appointed by the Minister by notification in the Gazette, being a date before the expiry of one year after such commencement, be exercised and discharged by such officer of the Ministry of Finance as may be specified by the Minister by order and during the aforesaid period the provisions of this Act shall be construed as if references to the Bank were references to such officer.

(3) The officer specified under subsection (2) and other officers and employees assigned by the Minister to assist him shall constitute the Off-Shore Banking Unit of the Ministry of Finance."

Insertion of the following as subsection (3):

"(3) The Bank, after consultation with eligible companies and qualified foreign banks engaging in the business of off-shore banking from Guyana, may prescribe that a ratio of their foreign exchange liabilities be lent to a foreign exchange facility of the Bank to be used to advance loans for the purpose of importing production materials to resident foreign exchange earners, the loans being secured by Guyana Government securities on terms prescribed by the Bank."

Clause 8 was thereafter passed with the following amendment:

Substitution of the word "shall" for the word "may" in subsection (1).

Clause 11 was passed as printed with the following correction to the marginal note:

Substitution of the words "in the hinterland of Guyana relating to mining, agriculture, or tourism or relating to the development or exploitation of such other natural resources of Guyana as may be notified by the Minister in the Gazette; and" for the words beginning with "of a mining" and ending with "of Guyana; and".

Clause 113 was then passed as amended.

Clauses 114 to 116 were passed as amended.

Clause 117 was passed as printed with the following correction:

Substitution of the word "Interest" for "interest" in the marginal note.

Clause 118 and 119 were passed as printed.

Assembly resumed.

On a motion by the Minister of Finance, the Bill was read the third time and passed as amended in Committee.

ADJOURNMENT

At 16:41 hrs, on a motion by the Minister of Manpower, Housing and Environment, the Assembly was adjourned to a date to be fixed.
