## <u>No. 5</u> - <u>Alleged Police Brutality, etc. - Notice Paper No. 28 published</u> <u>1986-04-10</u>

Mr. Kwayana asked the Parliamentary Secretary, Home Affairs, the following question:

- <u>QUESTION:</u> (i) Will the Parliamentary Secretary state whether there has been a departmental enquiry into the alleged police brutality against Mr. Anthony La Cruz of Moruca?
  - (ii) If there has been an enquiry, will the Parliamentary Secretary tell the National Assembly what are the findings of the enquiry?
  - (iii) If the answer to (i) is negative, will the Farliamentary Secretary say whether she proposes to hold or order such an enquiry?
  - (iv) Will the Parliamentary Secretary say whether a member of the Police Force in plainclothes duty has been tailing Mr. Balram Dhany of Three Friends, Essequibo?
    - (v) Will the Parliamentary Secretary further say whether this same policeman was authorised to approach the same Mr. Dhany and offer him a bribe or inducement for breaking his affiliation with the WPA and attaching himself to any other opposition political party?
  - (vi) Will the Parliamentary Secretary say whether the Commissioner of Police was instructed not to reply to letters from this member on the subject matter which forms the basis of questions (i) to (v)?
  - (vii) Is the Parliamentary Secretary aware that Mr. Bhairo of Stewartville, West Coast Demerara, a member of the W.P.A., was detained for a number of hours on March 24, 1986 at Leonora Police Station on the pretext of having committed the offence of claiming to be a policeman and questioned about the activities of the WPA?

(viii) Is it the present policy of the Ministry of Home Affairs or the Police Department to tail political activists of opposition parties not suspected of any offence and if so do the victims of this practice include Members of Parliament?

The Parliamentary Secretary, Home Affairs, gave the following reply:

- ANSWER: (i) The answer to question at (i) is 'yes'.
  - (ii) With respect to the question at (ii), three policemen alleged to have been involved in the incident have been charged with the offence of using unnecessary violence to a prisoner, contrary to section 4 (L) (11) of the Police (Discipline) Act, Chapter 17:01.
  - (iii) In the circumstances, the question at (iii) does not arise.
  - (iv) The answer to the question at (iv) is in the negative.
  - (v) In the circumstances, the question of (v) does not arise.
  - (vi) The answer to the question at (vi) is in the negative.
  - (vii) With respect to the question at (vii), the matters alleged are not within the knowledge of the Parliamentary Secretary. The Parliamentary Secretary does not concern herself with the dayto-day routine activities of the Police Force.
  - (viii) With respect to the question at (viii), the answer is in the negative.

(i) That the National Assembly urge the Government to seek the assistance of the relevant EEC-ACF institution for the establishment of a joint, high powered advisory Commission to be sponsored and and financed by the EEC, with important Caribbean technical, University, trade union and business representation, to pursue among others, the following terms of reference -

- (a) to make an objective and comprehensive study of the cane sugar industry in the Caribbean in its national and international setting, with projections into the future;
- (b) to examine means of rehabilitation of the industry, and at the same time explore alternative economic employment of the human and other resources at present employed in the industry in the Caribbean;
- (c) arising cut of (b) to identify and explore possible sources of devolopment finance;
- (d) to establish, if necessary, in an advisory sense, phases of action that involve the least possible level of social dislocation;
- (e) to submit a report or reports to the governments for their consideration and to ensure popular participation;

(ii) Further, that the objective and comprehensive study should bear in mind among other things the welfare of the existing labour force in the various countries, the need for an optimum level of foreign earnings for the Caribbean economies, and the need for Caribbean integration and economic development.
