The following charges are hereby prescribed for the supply of Electricity by the Corporation:

TARIFF NO. 1**GENERAL PURPOSE TARIFF**

| 1. | Application: | General Lighting for all premises including Signs, temporary services, etc. Not exceeding a monthly consumption of 100 KW hrs. |
| 2. | Service: | Low voltages single phase as applicable and available. |
| 3. | Monthly Energy Charge: | 21.5c per KW hr. |
| 4. | Monthly Minimum Charge: | 10 KW hrs. at 21.5c. per KW hr=\$2.15 |
| 5. | Deposit: | Equivalent to two months' estimated billing:
Minimum: Lights only \$15.00 |
| 6. | Fuel Cost Variation Clause: | The Fuel Cost Variation Clause published as Appendix 1 to these Tariffs shall apply to take account of variations in the cost to the Corporation of fuels used in the Corporation's Generating Plant. |

TARIFF NO. 2

RESIDENTIAL TARIFF

1. Application: Private residences having at least 500 watts in appliances or an electric refrigerator etc.
2. Service: Low and medium voltages, single and 3-phase as applicable and available.
3. Monthly Energy Charge: 25.26c. per KW hr.
4. Monthly Minimum Charge: 50 KW hrs. at 25.26c. per KW hrs = \$12.63. Plus Fuel Cost Surcharge on KW hrs consumed.
5. Deposit: Equivalent to two months estimated billing: Lighting/Iron & Radio — \$30.00

Minimum	2-wire	service	90.00
Minimum	3-wire	service	180.00
6. Fuel Cost Variation Clause: The Fuel Cost Variation Clause published as Appendix 1 to these Tariffs shall apply to take account of variations in the cost to the Corporation of fuels used in the Corporation's Generating Plant.

| 4. | Monthly Minimum Charge: | 50 KW hrs at 36.01c per KW hr. = \$18.01. Plus Fuel Fuel Cost Surcharge on KW hrs. consumed. |
| 5. | Deposit: | \$120.00 per KVA of installed capacity. |
| 6. | Fuel Cost Variation Clause: | The fuel Cost Variation Clause published as Appendix 1 to these Tariffs shall apply to take account of variations in the cost to the Corporation of fuels used in the Corporation's Generating Plant |

| 2. | Service: | Low and medium voltages, single and 3-phase as applicable and available. |
| 3. | Monthly Energy Charge: | 34.93 c. per KW hr |
| 4. | Monthly Minimum Charge: | 50 KW hrs. at 34.93c per KW hr.= \$17.47 Plus Fuel Cost Surcharge on KW hrs. consumed. |
| 5. | Deposit: | \$120.00 per KVA of installed capacity. |
| 6. | Fuel Cost Variation Clause: | The fuel Cost Variation Clause published as Appendix 1 to these Tariffs shall apply to take account of variations in the cost to the Corporation of fuels used in the Corporation's Generating Plant |

GUYANA ELECTRICITY CORPORATION

TARIFF NO. 5

BULK SUPPLY

1. **Application:** For all General Power, Industrial, Commercial and Residential purposes. Minimum connected load of 100 KVA. The proportion of the power required for industrial purposes shall not be less than 75% of the total connected load. The resale of energy under this Tariff is not allowed.

2. **Service:** Supply will be delivered directly from the primary voltage mains of the Corporation.

 Consumers will be required to supply without charge to the Corporation their own distribution transformer/transformers with the necessary protective devices to the required specification advised by GEC and suitable accommodation for the necessary primary voltage apparatus and metering equipment.

 Consumers who are unable to supply their own distribution transformer/transformers will not be allowed to be on Tariff No. 5 but instead on Tariff No. 4.

3. **Monthly Energy:** 27.95c. per KW hr.

4. **Monthly Minimum Charge:** 5,000 KW hrs. at 27.95c. per KW hr. = \$1,397.50. Plus Fuel Cost Surcharge on KW hrs. consumed.

5. **Deposit:** \$120.00 per KVA of installed capacity.

6. **Fuel Cost Variation Clause:** The Fuel Cost Variation Clause published as Appendix I to these Tariffs shall apply to take account of variations in the cost to the Corporation of fuels used in the Corporation's Generating Plant.
