DRAINAGE AND IRRIGATION ACT

(CHAPTER 64:03)

In accordance with the authority vested in the Drainage and Irrigation Board under section 45 of the Drainage and Irrigation Act, the Board has assessed as set out below additional rates to be paid for service in the year 1975 by proprietors within the undermentioned Sections of the Vergenoegen/Bonasika and Tapakuma Drainage and Irrigation Areas:

2. The Drainage and Irrigation rates for this area have been modified to 5 cents per acre per annum for the period 1960 — 1973. This said rate (5 cents per acre) would be applied until the Drainage and Irrigation Scheme is completed in 1975 or any earlier date.

3. Rates may be paid in equal moieties which shall be due for payment on the 1st day of February 1975, and the last day of July 1975. Each moiety shall be paid on or before the last day of the month in which payment is due and failure to pay the first moiety on or before the last day of February, 1975, shall render the whole amount immediately payable.

4. In accordance with SECTIONS 46 and 47 OF THE DRAINAGE AND IRRIGATION ACT, THE RATES SPECIFIED HEREIN ARE LIABLE TO BE VARIED BY THE MINISTER AND WITH HIS POWERS ENABLING, TO WHOM THESE ASSESSMENTS SHALL BE SUBMITTED.
