INSTRUMENT APPOINTING MEMBERS OF THE GUYANA MARKETING CORPORATION

WHEREAS by the Guyana Marketing Corporation Order, 1963, made under the Public Corporations Ordinance, 1962, provision is made for the establishment of a public corporation to be known as the Guyana Marketing Corporation with effect from the 14th December, 1964;

AND WHEREAS it is provided by subsection (2) of section 3 of the said Ordinance that a corporation shall consist of one official member and of such number of other members as the Council of Ministers may from time to time determine;

AND WHEREAS it is provided by subsection (4) of section 3 of the said Ordinance that a chairman and deputy chairman of a corporation shall be appointed by a Minister from among the members of the corporation;

AND WHEREAS it is provided by subsection (5) of section 3 of the said Ordinance that a member of a corporation may be appointed for any period not exceeding three years but shall be liable to be removed from office at the pleasure of the Council of Ministers;

NOW THEREFORE in pursuance of the said provisions and in accordance with the decision of the Council of Ministers that the Guyana Marketing Corporation shall consist of seven members (including the Official member) to be appointed by the Minister for the time being charged with responsibility for the subject of trade, I do hereby appoint the following persons as members of the Corporation for a period of one year with effect from the 14th December, 1964 —
