NOTICE UNDER THE ROADS ORDINANCE, CHAPTER 277.

WHEREAS by subsection (1) of section 18 of the Roads Ordinance, Chapter 277, the Director of Public Works has caused to be deposited in the office of the Public Works Department at Georgetown, in the county of Demerara, a Notice accompanied by drawings RS 117/1 — RS 117/45 of the proposed widening and deviation of the existing East Bank Demerara Public Road from La Penitence to Atkinson Field Gate between station 1/34.59 and station 1108/00 shown on the abovementioned drawings, a distance of 20.5 miles, save and except the following sections the deviations of which were previously determined or are in process of determination by the Governor:
