ASSIGNMENT OF RESPONSIBILITY TO MINISTERS

Under the Constitution of Guyana.

It is announced for general information that His Excellency the Governor-General in pursuance of the provisions of Article 36 of the Constitution of Guyana, and acting in accordance with the advice of the Prime Minister, has charged the Ministers mentioned in the first column of the Schedule to this Notice with responsibility for the matters and groups of matters set out against their respective names in the second column of that Schedule, and with responsibility for the Departments of Government set out against their respective names in the third column of that Schedule, with effect from the 1st February, 1969.

It is also announced that the Governor-General, acting in accordance with the advice of the Prime Minister has designated the style by which each such Minister should be known as set out against their respective names in the fourth column of the Schedule.
