

NOTICE  
INTERPRETATION ORDINANCE,  
(Chapter 5).

UNDER SECTION 39 OF THE INTERPRETATION ORDINANCE, IN ACCORDANCE WITH PARAGRAPH (1) OF ARTICLE 22 OF THE CONSTITUTION OF BRITISH GUIANA, AND BY VIRTUE AND IN EXERCISE OF ALL POWERS ENABLING HIM IN THAT BEHALF, HIS EXCELLENCY THE GOVERNOR ON THE 29<sup>TH</sup> DAY OF MAY, 1962, DEPUTED THE MINISTER OF EDUCATION AND SOCIAL DEVELOPMENT TO EXERCISE ON HIS BEHALF THE POWERS SPECIFIED IN THE FIRST COLUMN OF THE SCHEDULE TO THIS NOTICE CONFERRED ON THE GOVERNOR BY THE ORDINANCES MENTIONED IN THE SECOND COLUMN OF THE SAID SCHEDULE, SUBJECT HOWEVER TO THE FOLLOWING QUALIFICATION :—

That the delegation of powers mentioned herein shall remain in force only until varied or revoked by the Governor.

2. To terminate the appointment of any member of the Poor Law Commissioners board in case of his absence from the colony or for any other reason.	The Poor Relief Ordinance, Chapter 62. (Section 3(4) ).
3. To appoint a member of the Poor Law Commissioners board to be chairman of the board and any other member to be deputy chairman of the board.	The Poor Relief Ordinance, Chapter 62. (Section 3(5) ).
4. To declare and establish in any part of the colony outside the city of Georgetown districts for the purposes of administration of relief to the destitute poor.	The Poor Relief Ordinance, Chapter 62. (Section 13(1) ).
5. To alter the limits of any district established for the purposes of administration of relief to the destitute poor.	The Poor Relief Ordinance, Chapter 62. (Section 13(3) ).
6. To appoint a local board of guardians to administer poor relief.	The Poor Relief Ordinance, Chapter 62. (Section 13(4) ).
7. To terminate the appointment of any member of a local board of guardians for absence from the colony or for other reason.	The Poor Relief Ordinance, Chapter 62. (Section 13(5) ).

8. To appoint members of the Adoption Board.	The Adoption of Children Ordinance, 1955, No. 12 of 1955. (Section 3 (1) ).
9. To appoint the Chairman and the Deputy Chairman of the Adoption Board.	The Adoption of Children Ordinance, 1955, No. 12 of 1955. (Section 3 (3) ).
10. To grant leave of absence to any member of the Adoption Board and to appoint any person to act in the place of any member of the Board in case of the absence or inability to act of such member.	The Adoption of Children Ordinance, 1955, No. 12 of 1955. (Section 3 (7) ).
11. To revoke the appointment of any member of the Adoption Board.	The Adoption of Children Ordinance, 1955, No. 12 of 1955. (Section 3 (8) ).
