3. ACQUISITION OF THE UNDERTAKING CARRIED ON BY THE MAYOR AND TOWN COUNCIL OF NEW AMSTERDAM

The Minister of Energy and Natural Resources to move the following motion:

WHEREAS the Electricity Act, Chapter 56:01, provides for the Guyana Electricity Corporation to have the exclusive right to generate and sell energy within the areas prescribed in the First Schedule to the Act;

AND WHEREAS the Mayor and Town Council of New Amsterdam are empowered by the New Amsterdam Electric Lighting Order 1900 made under the Electric Lighting Ordinance 1890, as amended from time to time, to supply electricity to the area mentioned in the First Schedule to the said Order;

AND WHEREAS by virtue of the New Amsterdam Electric Lighting Order (Extension) Ordinance 1961 and the New Amsterdam Electric Lighting Order (Extension)(Amendment) Act 1971 the Order continues in force until 1st January 1981;

AND WHEREAS it is provided by section 24(1) of the Electricity Act, Chapter 56:01, that the Electricity Corporation may acquire the undertaking of any local authority or person authorised to supply electricity within an area;

AND WHEREAS such provision requires a resolution of the National Assembly that it is in the public interest that the undertaking of the Mayor and Town Council of New Amsterdam for the supply of electricity should be managed and worked by the Electricity Corporation:

BE IT RESOLVED:

That it is in the public interest that the undertaking carried on by the Mayor and Town Council of New Amsterdam should be acquired by the Guyana Electricity Corporation.
