A BILL intituled AN ACT TO ESTABLISH A SYSTEM OF NATIONAL INSURANCE AND SOCIAL SECURITY PFOVIDIVG PECUNLARY PAYMENNS BY WAY OF OLD aGs BENEFIT, INVALIDITY BEIRFIT, SURVIVOR'S BENEFIT, SICKNESS BENEFTT, MATERNITY BENEFIT AND FUNERAL BENEFIT, AND TO SUBSTITUTE FOR COMPEISATION UNDER THE WORKMEN'S COMPGNSATION ORDINANCE A SYSTEM OF DNSURANGE AGAINST INJURY OR DEATH CAUSED BY ACCIDENT ARISING OUT OF AND IN THE COURSE OF EMPLOYMENI OR RESULTING FROM DISEASE DUE TO THE NATURE OF EMPLOYMENT; TO ESTABLISA A. NATIONAL INSURINCE FUND; AND TO PROVIDE FOR MATTERS CONNECTED WITH OR INCIDENTAL THERETO.
