GUARANTEE OF LOAN BY CHASE MANHATTAN BANK, N.A.

* The Minister of Finance to move the following motion:

WHEREAS on the 1st day of June, 1971, the National Assembly by Resolution approved of the Government of Guyana guaranteeing the repayment of a short-term loan of four million dollars (U.S.) to be made by the Chase Manhattan Bank, N.A., to the Guyana Development Corporation for a period of twelve months in relation to the take-over of the Demerara Bauxite Company, Limited;

AND WHEREAS subsequent to that Resolution the Guyana Bauxite Company, Limited, has been incorporated and registered on the 3rd day of June, 1971 and it is the purpose of the Government of Guyana to vest in that Company the assets of the Demerara Bauxite Company, Limited, acquired by the State pursuant to the Bauxite Nationalisation Act, 1971;

AND WHEREAS the Guyana Bauxite Company, Limited, is to be made a party to the said loan of four million dollars (U.S.) to be made by the Chase Manhattan Bank, N.A.:

BE IT RESOLVED:

That the Assembly approve of the Government of Guyana guaranteeing the repayment of a short-term loan of four million dollars (U.S.) to be made by the Chase Manhattan Bank, N.A. to the Guyana Bauxite Company, Limited, jointly with the Guyana Development Corporation, for a period of twelve months in relation to the take-over of the Demerara Bauxite Company, Limited.
