WHEREAS by Agreement of 11th July, 1968, between the Government of Guyana, the Commonwealth Development Corporation and the Guyana Mortgage Finance Company, Limited, the said Corporation and the said Company agreed to provide financing for housing development in Guyana;

AND WHEREAS under the terms of the said Agreement the Government agreed to take such action as may be necessary to enable the Guyana Mortgage Finance Company, Limited, to be exempted from the application of the Property Tax Ordinance 1962;

AND WHEREAS paragraph (w) of section 6 of the said ' Ordinance authorises the National Assembly, by resolution, to exempt from the provision of the said Ordinance any person or authority other than those specified in the said section 6:

NOW, THEREFORE, BE IT RESOLVED:

That in pursuance of the said Agreement and of the aforesaid provision of the said Ordinance, the Guyana Mortgage Finance Company, Limited, shall be exempt from the provisions of the said Ordinance with effect from. 11th July, 1968.
