That this Council recommends to Government the immediate preparation and implementation of an extensive and thorough scheme for the training of Guianese with a view to the latter's filling all the higher posts in the administrative and technical branches of the country's Public Service.

7. Mr. Jai Narine Singh to move the following motion:

BE IT RESOLVED:

That this Council records its protest against the appointment by the Secretary of State for the Colonies of a non-Guianese as Postmaster General of British Guiana, and recommends to Government that steps be taken to continue unbroken the accepted policy of Guianization of the Civil Service.
