MOTION

The Minister of Trade and Industry to move the following motion:

WHEREAS the Commissioner of Title (Additional Powers) Ordinance, 1960, was enacted on the 3rd November, 1960, and came into force on the 5th November, 1960, by publication in the Official Gazette;

AND WHEREAS section 4 of the said Ordinance construed in accordance with section 20 of the British Guiana (Constitution) Order in Council, 1961, provides that the Ordinance shall have effect for a period of one year from the date of its coming into force, and may, prior to its expiration, be extended by resolution of the chambers of the Legislature for a further period not exceeding one year;

AND WHEREAS the said Ordinance will continue in force until the 4th November, 1961;

AND WHEREAS it is considered desirable that the said Ordinance shall be continued in force for a further period of one year:

NOW, THEREFORE, BE IT RESOLVED that the Commissioner of Title (Additional Powers) Ordinance, 1960, shall continue in force for a period of one year up to and including the 4th November, 1962.
