PUBLIC BUSINESSMOTIONS:

1. The Minister of Finance to move the following motion:

BE IT RESOLVED:

That this Legislative Assembly approves of the payment of salaries to Public Servants with effect from 1st January, 1961, at the rates set out in the Report of the Commission to Review Wages, Salaries and Conditions of Service in the Public Service, British Guiana, 1961, as modified by the Government in Sessional Paper No. 3 of 1962 pending final consideration in the light of the decisions arising from discussion in Whitley Council,

BE IT FURTHER RESOLVED:

That in terms of section 13 of the Financial Administration and Audit Ordinance, 1961 (No. 39), this Legislative Assembly authorises the expenditure of \$2,600,000 required to meet the payment of arrears of salaries on the aforementioned basis in respect of the year 1961.

2. The Minister of Finance to move the following motion:

BE IT RESOLVED:

That this Legislative Assembly authorises the expenditure of \$81,000 for the purchase and alteration of premises situate at S $\frac{1}{2}$ Lot 21 Brickdam, Georgetown, to accommodate the Ministry of Education and Social Development.
