That this National Assembly refers the recommendations of the Guyana Fiduciary Oversight Project Report (The Bradford Report) to the Select Committee already established by the National Assembly on 27th October, 2005;

BE IT FURTHER RESOLVED:

That the said Committee consider the Needs Assessment of the Guyana National Assembly Report and its Addendum and the Guyana Fiduciary Oversight Project Report (The Bradford Report) so that all recommendations relating to the oversight role of the National Assembly may be comprehensively considered and reported on to the National Assembly by January 31, 2006.

That this National Assembly authorises its Economic Services Sector Committee to monitor the work of the cross sectional group and receive monthly interim progress Reports and the updated National Development Strategy and to make specific recommendations to the National Assembly for the implementation of the said updated National Development Strategy.
