WHEREAS WE Amerindian Act, Chapter 29:01, section 16, provides for the establishment of Amerindian Councils for the control of lands that fall within the boundaries of each Amerindian settlement: **BE IT RESOLVED:**

That squatters occupying lands in Amerindian settlements, as in the case of Capoey Amerindian settlement, Essequibo, be removed forthwith and the Amerindian Council be allowed to develop the lands without interference and hindrance.

*3. REVIEW OF CONSTITUTION,

Cde. K'B' Bancroft to move the following motion:

WHEREAS the present Constitution of Guyana was promulgated on 6th October, 1980;

AND WHEREAS a Constituent Assembly had been established to take evidence from the public and to submit a draft Constitution to the National Assembly;

AND WHEREAS the said draft Constitution was debated in the National Assembly and, with some amendments, was passed into law as the present Constitution;

AND WHEREAS the foople's Progressive Perty, the largest minopity party in the Mational Assembly, had boycotted the Constituent Assembly and made no contribution to the fashioning of the present Constitution;

AND WHEREAS on 6th October, 1990, the said Constitution would have been in existence for a decade;

AND WHEREAS it seems appropriate and timely to review the said Constitution to see how well its various provisions have worked in securing its objectives of a democratic society based on the Rule Law in which all citizen's can find full scope for participation in the social, cultural and political life of the country;

BE IT RESOLVED:

That this National Assembly appoint a select committee to study this issue and report to the National Assembly its opinion on whether it is desirable and appropriate that the Constitution be reviewed;

That should the Select Committee report in the affirmative, the National Assembly urge the Government to set in train appropriate processes for a National review of the Constitution.
