IN EXERCISE OF THE POWER CONFERRED ON THE ELECTIONS COMMISSION BY SECTION 15(1) OF THE NATIONAL REGISTRATION ACT, Cap 19:08, AS AMENDED BY SECTION 5 OF THE NATIONAL REGISTRATION AMENDMENT ACT, (NO. 2) OF 2005 AND REGULATION 14(1) OF THE NATIONAL REGISTRATION (RESIDENTS) REGULATIONS, THE ELECTIONS COMMISSION MAKES THE FOLLOWING ORDER:-

1. This Order may be cited as the National Registration (Residents) (Revision of Registers) Order 2017. Citation.
2. The Registration Officer of every Registration District in the first Schedule is required to prepare a register of voters for that registration district. Revision of Registers
3. The 30th June, 2017 shall be the qualifying date with reference to which an Official List of Electors shall be compiled in pursuance of this Order. Qualifying date.
4. The days set out in the second column of the Second schedule shall be the days with reference to which the matters set out in the corresponding entry in the first column thereof shall be done. Other matters prescribed. Second Schedule.



1. The day not later than which the Commissioner of Registration shall publish the Preliminary List under section 14(1) of the National Registration Act (Cap 19:08).	15 th April, 2017
2. The days to be specified in the notice in which applications may be made for registration and on which applications may be made by persons whose names appear in the preliminary list for change and correction of particulars as shown in the list.	April 24 st May 14 th , 2017 (Both days inclusive)
3. The days on which objections may be tendered to the registration officer of each registration district against the inclusion of names on the preliminary list.	April 24 st May 19 th , 2017 (Both days inclusive)
4. The day not later than that which the Registration Officer shall begin to hear and determine objections and appeals.	May 15 th , 2017

5. The day not later than which all forms of applications for registration, change and correction of particulars shall be sent by the Registration Officer to the Commissioner of Registration.	May 18 th , 2017
6. The day not later than which all forms of objections and appeals upheld shall be sent by the Registration Officer to the Commissioner of Registration.	21 May, 2017
7. The day not later than which the Commissioner of Registration shall correct the Preliminary List.	3 rd June, 2017
