IN EXERCISE OF THE POWERS
CONFERRED UPON THE MINISTER
BY SECTION 10 OF THE MINING ACT, 1989
I HEREBY MAKE THE FOLLOWING ORDER:

1. This Order may be cited as the **Citation and Commencement**
Guyana Geology and Mines
Commission (Prospection for
Gold, Valuable Minerals
Precious Stones, Precious
Metals, Base Metals and
Industrial Minerals) (No.)
1 Reservation Order 2000 and
shall be deemed to have come
into operation on the 1st day of
November 2000.
2. The areas hereinafter described **Reservation**
In the Schedule below are
Hereby reserved for prospecting
Operations by the Guyana
Geology and Mines
Commission; but WITHOUT
PREJUDICE to the power of the
Minister (as representing the
State) to permit any person to
carry on in the scheduled area
prospecting operations
(including operations incidental
thereto) for the benefit, wholly
or partly, of the Guyana
Geology and Mines Commission.

Schedule

AREA A: PURUNI

A tract of state land located in Mining District No. 3 as shown on Topographic Sheets 16SE, 17SW, 24NE, 25NW is described as follows:

From a reference Point Y' located at the mouth of the Komang River (Right Bank Cuyuni River), with approximate geographic coordinates, Latitude $6^{\circ}54'00''$, Longitude $60^{\circ}21'36''$; thence at a true bearing of --- for a distance of approximately 31.0 km to

Point A located with approximate geographical coordinates, Latitude: $6^{\circ}39'21''$; Longitude: $60^{\circ}14'09''$; thence at a true bearing of approximately 90° for a distance of approximately 41.0 km to a Point B' located with approximate geographical coordinates, Latitude: $6^{\circ}39'21''$; Longitude: $59^{\circ}51'54''$; thence at a true bearing of approximately 180° for a distance of approximately 38.02 km to a Point C' located with approximate geographical coordinates, Latitude: $6^{\circ}18'43''$, Longitude: $59^{\circ}51'54''$; thence at a true bearing of 270° for a distance of approximately 41.0 km to a Point D' located with approximate geographical coordinates, Latitude: $6^{\circ}18'43''$, Longitude: $59^{\circ}51'54''$; thence at a true bearing of approximately 360° for a distance of approximately 38.02 km to the Point of Commencement A', and enclosing an area of approximately 156,700 hectares, save and except all lands lawfully held or occupied.

AREA B: KABURI

A tract of state land located in Mining District No. 2 & 3 as shown on Topographic Sheets 35NE, SE, 36NW, SW, 43NE, 44NW is described as follows:

From a reference Point X' located at the mouth of the Itaki River with approximate geographic coordinates, Latitude $5^{\circ}56'56''$, Longitude $59^{\circ}11'16''$; thence at a true bearing of 175° for a distance of approximately 13.11 km to

Point A located with approximate geographical coordinates, Latitude: $5^{\circ}49'55''$; Longitude: $59^{\circ}10'58''$; thence at a true bearing of approximately 90° for a distance of approximately 45.69 km to a Point B' located with approximate geographical coordinates, Latitude: $5^{\circ}49'55''$; Longitude: $59^{\circ}46'12''$; thence at a true bearing of approximately 180° for a distance of approximately 40.92 km to a Point C' located with approximate geographical coordinates, Latitude: $5^{\circ}27'50''$, Longitude: $59^{\circ}46'12''$; thence at a true bearing of 270° for a distance of approximately 45.69 km to a Point D' located with approximate geographical coordinates, Latitude: $5^{\circ}27'50''$, Longitude: $59^{\circ}10'58''$; thence at a true bearing of approximately 360° for a distance of approximately 40.92 km to the Point of Commencement A', and enclosing an area of approximately 187,000 hectares, save and except all lands lawfully held or occupied.

AREA C: MORABISI

A tract of state land located in Mining District No. 3 as shown on Topographic Sheets 25SE, 26SW, 34NE, 35NW is described as follows:

Commencing at a

Point A located with approximate geographical coordinates, Latitude: $6^{\circ}22'5''$; Longitude: $59^{\circ}41'2''$; thence at a true bearing of approximately 90° for a distance of approximately 39.17 km to a Point B' located with approximate geographical coordinates, Latitude: $6^{\circ}22'5''$; Longitude: $59^{\circ}19'44''$;

thence at a true bearing of approximately 180° for a distance of approximately 41.28 km to a Point C' located with approximate geographical coordinates, Latitude: $5^{\circ}59'49''$, Longitude: $59^{\circ}19'44''$; thence at a true bearing of 270° for a distance of approximately 39.17 km to a Point D' located with approximate geographical coordinates, Latitude: $5^{\circ}59'49''$, Longitude: $59^{\circ}41'2''$; thence at a true bearing of approximately 360° for a distance of approximately 41.28 km to the Point of Commencement A', and enclosing an area of approximately 161,700 hectares, save and except all lands lawfully held or occupied.

AREA D: MABURA

A tract of state land located in Mining District No. 2 as shown on Topographic Sheets 44NW, NE, SW, SE is described as follows:

Commencing at a

Point A located with approximate geographical coordinates, Latitude: $5^{\circ}30'00''$; Longitude: $58^{\circ}54'07''$; thence at a true bearing of approximately 90° for a distance of approximately 44.50 km to a Point B' located with approximate geographical coordinates, Latitude: $5^{\circ}30'00''$; Longitude: $59^{\circ}46'12''$; thence at a true bearing of approximately 180° for a distance of approximately 54.60 km to a Point C' located with approximate geographical coordinates, Latitude: $5^{\circ}00'39''$, Longitude: $59^{\circ}46'12''$; thence at a true bearing of 270° for a distance of approximately 44.50 km to a Point D' located with approximate geographical coordinates, Latitude: $5^{\circ}00'39''$, Longitude: $58^{\circ}54'07''$; thence at a true bearing of approximately 360° for a distance of approximately 54.60 km to the Point of Commencement A', and enclosing an area of approximately 242,900 hectares, save and except all lands lawfully held or occupied.
