IN EXERCISE OF THE POWERS CONFERRED UPON ME BY SECTION 5 OF THE PUBLIC CORPORATIONS ACT 1988, AS APPLIED TO THE DEMERARA WOODS LIMITED BY NOTIFICATION UNDER SECTION 66 OF THAT ACT, I HEREBY MAKE THE FOLLOWING ORDER:—

1. This Order may be cited as the Demerara Woods Limited (Vesting of Property) Order 1991 and shall come into operation on 15th April, 1991.

Citation.

2. In this Order "Company" means the Demerara Woods Limited, being a Company incorporated under the Companies Act and wholly owned by the State and to which section 5 of the Act has been made applicable with modifications by the President by notification dated 21st March, 1991.

Interpretation Cap. 89:01

3. The items of immovable property of the State described in the Schedule, and which are at present in the possession of the Company, are hereby vested in the Company

SCHEDULE

IMMOVABLE PROPERTY OF THE STATE

VESTED IN THE DEMERARA WOODS LIMITED

- (1) Tract comprising portions of Mud Lots 14, 13, 12 and 11, being sub-lots "A", "B", "C", and "D" respectively, all being portions of Kingston, situate in the City of Georgetown in the County of Demerara, Guyana and containing nought decimal three nought eight (0.308), nought decimal six six two (0,662) nought decimal six nought nine (0.609) and nought decimal nought eight three (0.083) of an acre respectively and shown on Plan by R. Duesbury, Sworn Land Surveyor, dated 12th July, 1990 and recorded in the Department of Lands and Surveys as Plan No. 23434, and the erections and buildings thereon belonging to the State, but excluding the buildings or erections owned by or in the possession of the Forest Industry Development Unit located in the said tract.

- (3) Tract "D" being portion of State Land situate at Mabura Hill, Upper Demerara, in the county of Demerara, Guyana and containing seventy-three decimal six one six (73.616) acres and shown on a Plan by R. N. Durbeej, Sworn Land Surveyor, dated 7th January, 1991 and recorded as Department of Lands and Surveys Plan No. 23368.
- (4) Tract "B" being portion of State Land situate at Mabura Hill, Upper Demerara, in the County of Demerara, Guyana and containing one hundred and thirty-eight decimal five one (138.51) acres and shown on a Plan by R. N. Durbeej, Sworn Land Surveyor, dated 7th January, 1991 and recorded as Department of Lands and Surveys Plan No. 23368.
